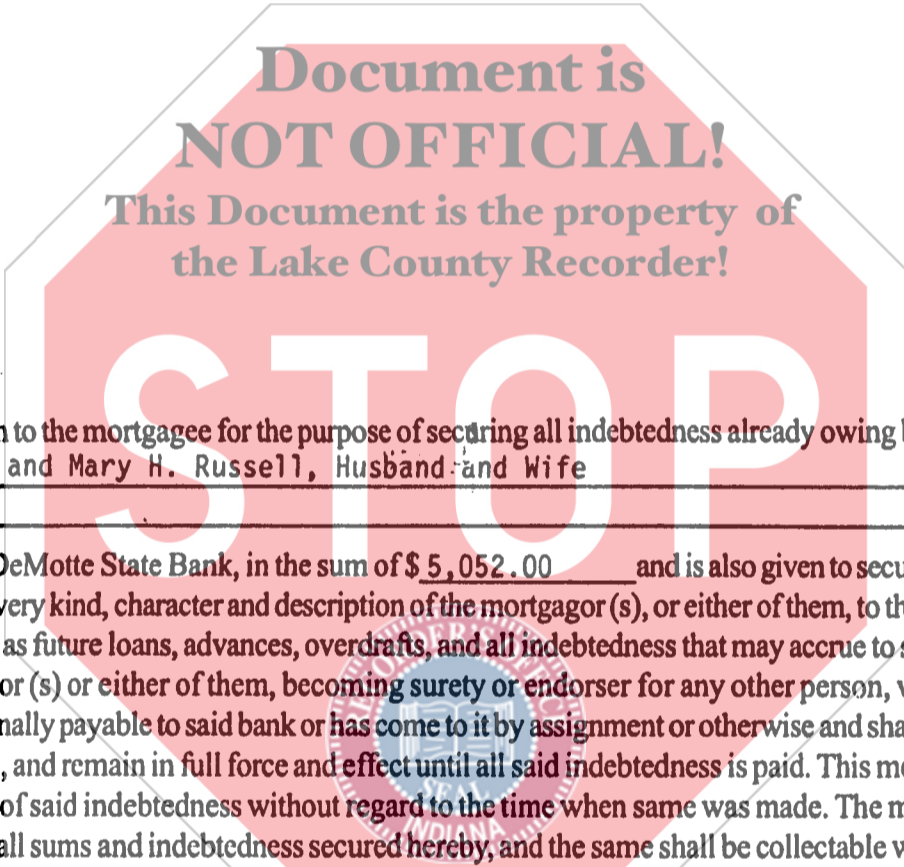

**INDEMNIFYING MORTGAGE**
