**ORDER DIRECTING THE AUDITOR OF LAKE COUNTY, INDIANA TO ISSUE TAX DEED**

Petitioner, Lake County Board of Commissioners, having previously filed a Petition for Issuance of Tax Deed directing the Auditor of Lake County, Indiana, to issue Tax Deed (H.I.). And the court being duly advised, now finds:

1. That the time for redemption has expired;
2. The real property has not been redeemed from the sale;
3. That all taxes and special assessments, penalties, and costs have been removed;
4. That all notices required by law have been given;
5. That the petition has complied with all the provisions of law entitling it to a deed.
