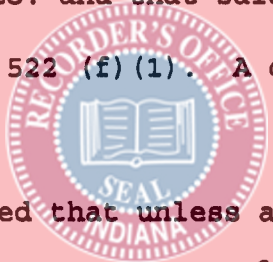

MOTION TO AVOID JUDICIAL LIEN!

Pursuant to Bankruptcy Rules 4003 (d) and 9014, the Debtor, by his Attorney, represent as follows:

1. The Creditor, Norwest Financial Co., has a judicial lien on the following described property of the Debtor:

Lots 13 and 14, Block 20, in the Great Gary Realty Co's First Addition to the City of Gary, as per plat thereof, and recorded in Plat Book 11 page 8, in the Office of the Recorder of Lake County, Indiana. Commonly known as: 3851 Tennessee Street, Gary, Indiana. Key number: 43-364-13

Said lien being place on or about the 23rd day of July, 1996, after the effective date of the current Bankruptcy Statute.

2. The lien of said creditor impairs an exemption to which the Debtor would have been entitled under the laws of the State of Indiana and the United States, which exemption has been claimed by the Debtor in the Schedules A & C filed by the Debtor in this case, which exemption has been allowed.
