Parcel 1: The East 175 feet of the North 1/2 of the Northeast 1/4 of Section 1, Township 33 North, Range 10, West of the Second Principal Meridian, containing 5.59 acres, in Lake County, Indiana.

Parcel 2: Part of the East 350 feet of the South 1/2 of the South 1/2 of the Southeast 1/4 of the Southeast 1/4 of Section 36, Township 34 North, Range 10, West of the Second Principal Meridian, more particularly described as follows: Beginning at the Southeast corner of said East 350 feet, thence Westerly along the South line thereof 175.00 feet; thence Northerly parallel with the East line of said East East 350 feet for a distance of 250.00 feet, thence Easterly parallel with said South line 175.00 feet to the East line of said East 350 feet; thence South along said East line 250.00 feet to the point of beginning, containing 1.00 acre, in Lake County, Indiana.

Parcel 3: Part of the Southwest 1/4 of the Southwest 1/4 of Section 31, Township 34 North, Range 9, West of the Second Principal Meridian, more particularly described as follows: Beginning at the Southwest corner of said quarter quarter, thence Northerly along the West line thereof 250.00 feet; thence Easterly parallel with the South line thereof 125.00 feet; thence Northeasterly to a point in the East line thereof, said point being 1200.00 feet North of the Southeast corner thereof; thence South along said East line 1200.00 feet to the Southeast corner of said Quarter Quarter; thence Westerly along the South line thereof 1191.12 feet to the point of beginning, containing 18.45 acres, in Lake County, Indiana
