### TAX TITLE DEED TO COUNTY RECORDER

WHEREAS, Lake County did, on the 6<sup>th</sup> day of December, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 15<sup>th</sup> day of March, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 15<sup>th</sup> day of March, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Eight Thousand Four Hundred Ninety One Dollars and eighty cents (\$8,491.80), being the amount due on the following tracts of land returned delinquent in the name DAVIS ARTHUR & WILHEMINA for 1998 and prior years, namely:

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given.
