

PARTIAL RELEASE OF RIGHT OF WAY CONTRACT

Subject to the exceptions and reservations hereinafter set forth, Marathon Pipe Line Company, a Delaware corporation, being the owner of that certain Right of Way Contract from Louis Plowman and Lena Plowman, his wife, dated June 10, 1957, and recorded in Book 696, Page 557-58, of the Records of Lake County, Indiana, does hereby release and surrender unto the present owners as their interest appears of record, their heirs and assigns, all of its right, title and interest in and under the aforesaid Right of Way Contract covering the following described lands (hereinafter referred to as "said lands") in the County of Lake, State of Indiana:

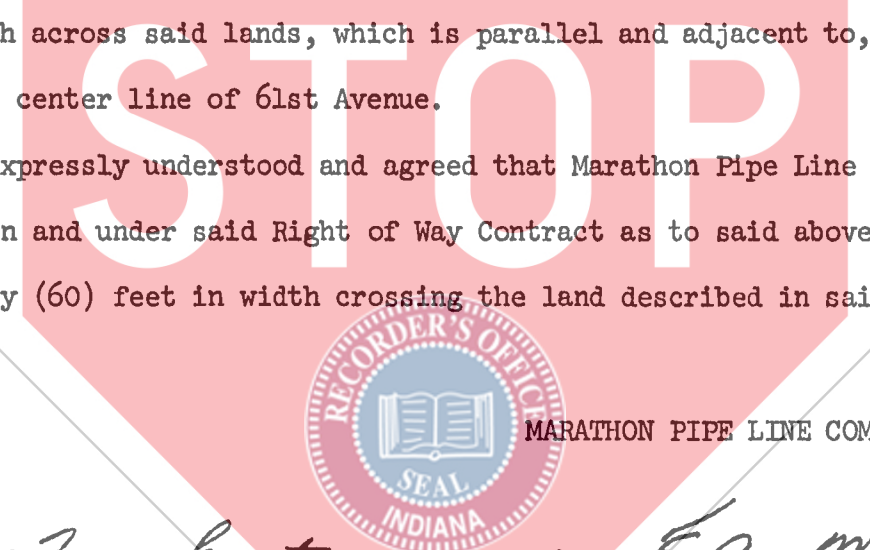

Part of the East Half (E $\frac{1}{2}$) of the Northeast Quarter (NE $\frac{1}{4}$) of the North West Quarter (NW $\frac{1}{4}$) of Section 10, Township 35 North, Range 8 West of the 2nd P.M., described as: Commencing on the North line of said half Quarter Quarter (1/4) Section at a point 379.86 feet East of the North West corner thereof and running thence South parallel to the West line of said half Quarter Quarter (1/4) Section 330.72 feet; thence East parallel to the North line of said Section 126.62 feet; thence North parallel to the West line of said half Quarter Quarter (1/4) Section 330.72 feet to a point on the North line thereof; thence West along said North line 126.62 feet to the place of beginning, containing .955 acre, more or less, in Lake County, Indiana.
