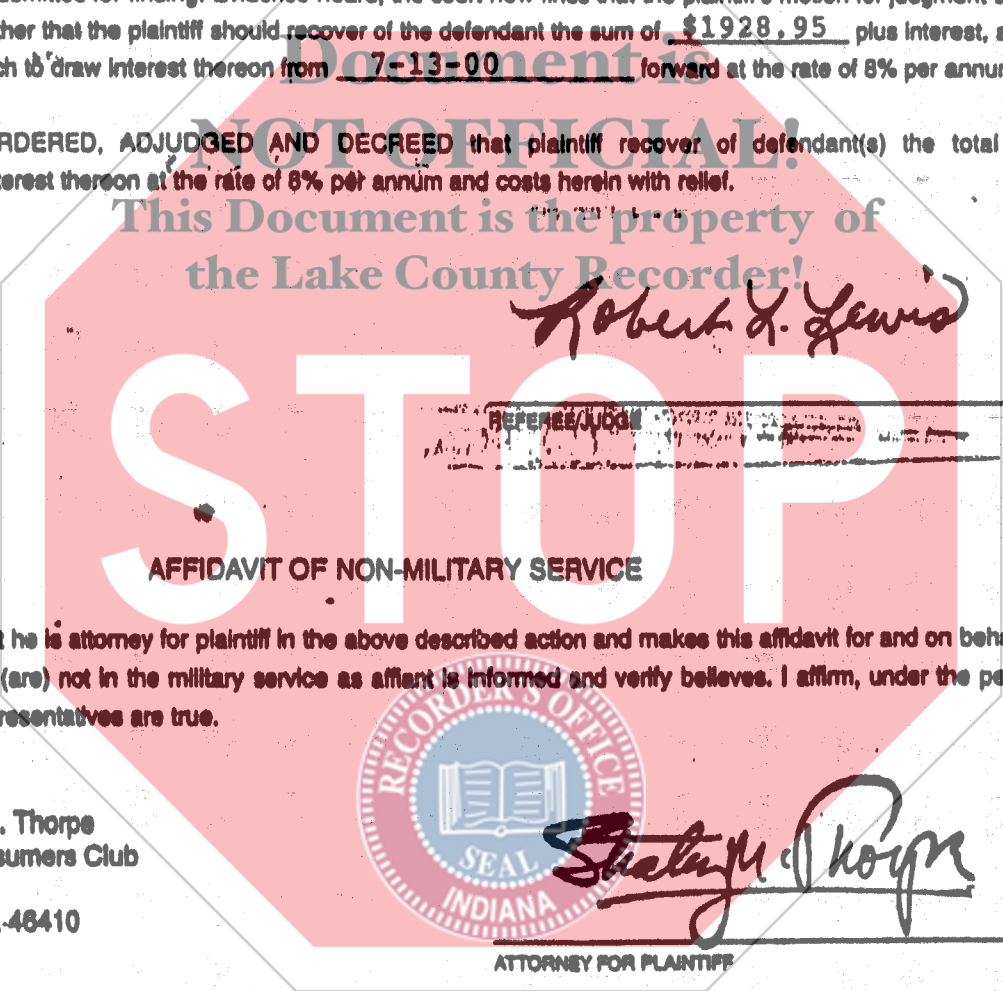

**DEFAULT JUDGMENT**

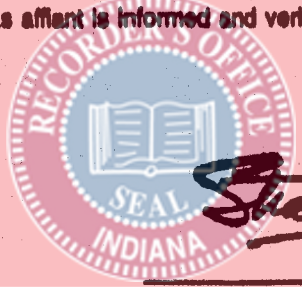
