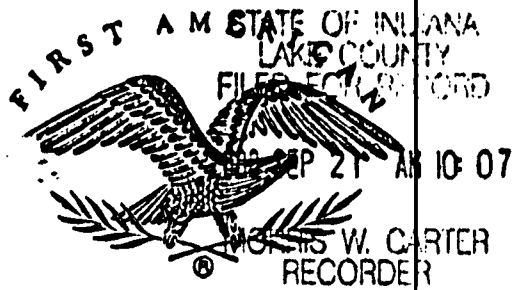

LEGAL DESCRIPTION

That part of the West half of the East half of Lot 5, in Section 16, Township 36 North, Range 7 West of the Second Principal Meridian, in the Town of East Gary, Lake County, Indiana, described as follows: Beginning at a point on the North right of way line of the M.C. Railroad, which is 317.92 feet Westerly of the intersection of the East line of said Lot 5 with the said North right of way line of the M.C. Railroad, thence North a distance of 333.79 feet along a line which produced North to the North line of said Lot 5, intersects the said North line of Lot 5 at a point which is 326.38 feet West of the Northeast corner of said Lot 5; thence East at right angles to the said last described line, a distance of 156.80 feet to the East line of said West half of the East half of Lot 5; thence South along the East line of the said West half of the East half of Lot 5 a distance of 295.19 feet to the North right of way line of the M.C. Railroad; thence Westerly along the North right of way line of the M.C. Railroad, a distance of 158.96 feet, more or less, to the place of beginning, in Lake County, Indiana.
