Hoch and Dolores J. Hoch, as Trustees, under the provisions of the HOCH LIVING TRUST, dated September 06, 2000, the following described real estate in Lake County, Indiana, to-wit:

and (d) if the conveyance is made to a successor or successors in trust, that the successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

This conveyance is made upon the express understanding and condition that Randall E. Hoch and Dolores J. The interest of each and every beneficiary hereunder and under the Trust Agreement and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or any other disposition of the real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to the real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid, the intention hereof being to vest in Randall E. Hoch and Dolores J. Hoch, as Trustees, the entire legal and equitable title in fee simple, in and to all of the real estate above described.
