**SWORN STATEMENT OF INTENT TO HOLD LIEN



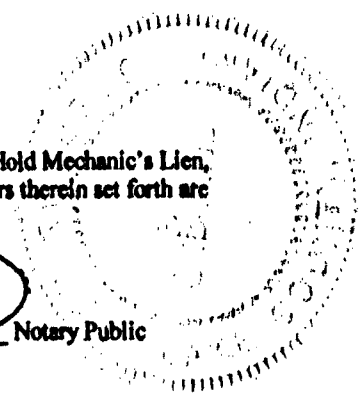
