That part of the Northeast Quarter of Section 32, Township 35 North, Range 7 West of the 2<sup>nd</sup> Principal Meridian described as beginning at a point which is on the North line of said Northeast Quarter and 1498.0 feet West of the Northeast corner thereof; thence due South parallel with the East line of said Northeast Quarter a distance of 1362.39 feet to a point on the Northerly right-of-way line of the Chesapeake and Ohio Railroad Company; thence North 60°-04'-00" West along said right-of-way line a distance of 398.09 feet; thence due North parallel with the East line of said Northeast Quarter a distance of 1166.88 feet to a point on the North line of said Northeast Quarter; thence South 89°-28'-40" East a distance of 345.0 feet to the point of beginning, all in Lake County, Indiana, containing 10.0158 acres, more or less.

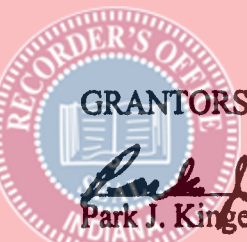
