THIS MEMORANDUM OF LEASE made September 6, 2000, between:

Legal Description

Part of the SE-1/4, NW-1/4 Section 17,1 Township 34 North, Range 8 West of the 2nd P.M. described as follows: Commencing at the Southwest corner of said 1/4 Section (said Southwest corner being 1,328.00 feet West of the center of said Section 17); thence East 320 feet along the South line of said Quarter Quarter Section to the Southwest corner of the Walgreen's parcel; thence continuing South 89 degrees 57 minutes 45 seconds East along the South line of said Walgreen's parcel 387.00 feet to the Southeast corner of said Walgreen's parcel and the point of beginning of this described parcel; thence North 00 degrees 12 minutes 35 seconds West 229.61 feet along the East line of said Walgreen's parcel to the Northeast corner of said Walgreen's parcel; thence along the North line of said Walgreen's parcel South 89 degrees 57 minutes 45 seconds West, 195.60 feet to the face of an existing brick wall; thence following said brick wall South 00 degrees 02 minutes 15 seconds East, 0.73 feet; thence South 89 degrees 57 minutes 45 seconds West, 2.10 feet; thence North 00 degrees 02 minutes 15 seconds West, 0.73 feet; thence South 89 degrees 57 minutes 45 seconds West, 68.30 feet; thence leaving said wall South 00 degrees 12 minutes 35 seconds East, 26.00 feet to a point 203.61 feet North of the South line of the NW-1/4 of said Section 17; thence South 89 degrees 57 minutes 45 seconds West, 121.00 feet to a point 320.00 feet East of the West line of the SE-1/4, NW-1/4 of said Section 17; thence North 00 degrees 13 minutes 15 seconds West parallel to said West line 326.24 feet to the North line of the South 32 rods of the SE-1/4, NW-1/4 of said Section 17; thence North 89 degrees 58 minutes 28 seconds East, 515 feet to a point 835 feet East of the West line of the SE-1/4, NW-1/4 of said Section 17; thence South 00 degrees 13 minutes 15 seconds East, 529.74 feet to the South line of the NW-1/4 of said Section 17; thence South 89 degrees 57 minutes 45 seconds West, 117.00 feet to the point of beginning,

TOGETHER WITH ALL RIGHT, TITLE AND INTEREST OF LESSOR IN THE FOLLOWING EASEMENTS:

- A. That certain Common Area Easement and Agreement dated September 8, 1978, and recorded November 14, 1978, in Book 49, Page 109, as Document No. 502429 in the Office of the Recorder of Lake County, Indiana; and
- B. Sewer line easement twelve feet (12') wide and approximately three hundred twenty feet (320') feet long extending from the Northwest corner of the above-described property westward to Court Street
