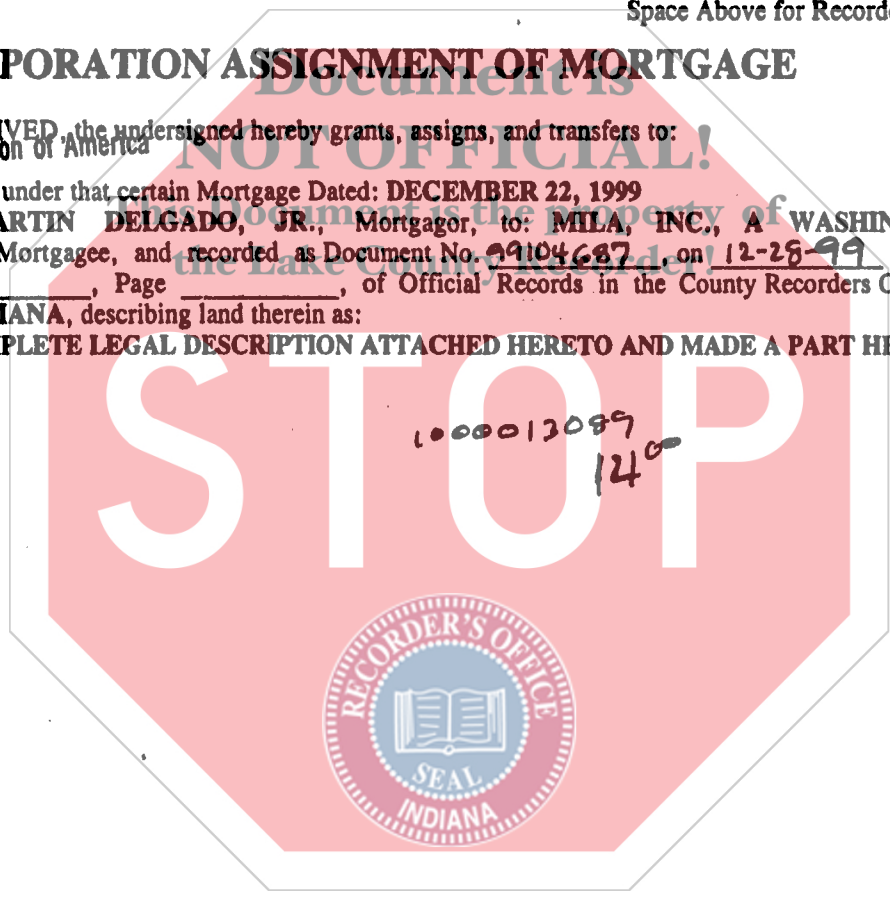

Part of the Southeast 1/4 of the Southwest 1/4 of Section 18, Township 36 North, Range 7 West of the 2nd Principal Meridian, In Lake County, Indiana, described as follows:

Beginning at a point 33 feet North and 33 feet West of the Southeast corner thereof; thence North 204.87 feet to a point on the Southerly line of Lake Street (as shown on the recorded plat of First Subdivision of East Gary In Plat Book 7 page 9); thence Southwesterly along the Southerly line of Lake Street, 297.46 feet to the East line of Arch Street (as shown on Plat Book 7 page 9); thence South on the East line of said Arch Street, 64.05 feet to a point 33 feet North of the South line of said 1/4 1/4 Section; thence East 264 feet to the place of beginning.
