Together with the rents and profits therefrom, to secure the payment, when the same shall become
due, of the following indebtedness: the sum of \$261.00 Dollars the same being amounts
due and payable for repayment of poor relief benefits for the period from 4-6-99
_____, not otherwise satisfied by resources of the mortgagor or having been earned by
reason of workfare contribution under the poor relief laws of the State on Indiana.
