FINAL RELEASE OF MECHANIC'S LIEN



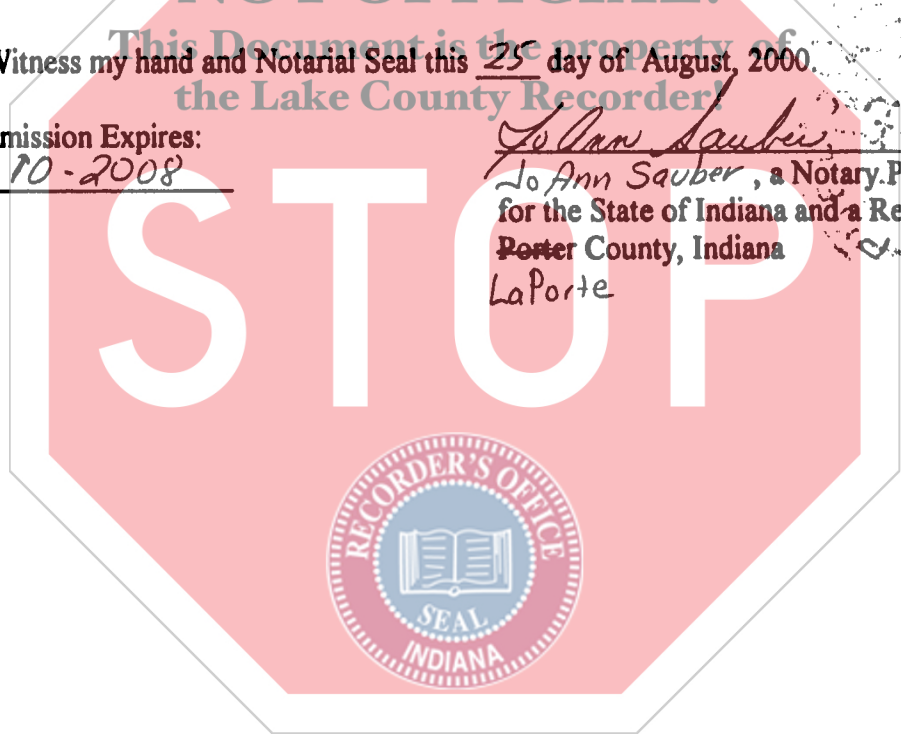
