17, in the Office of the Recorder of Lake County, Indiana.

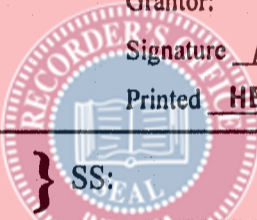
