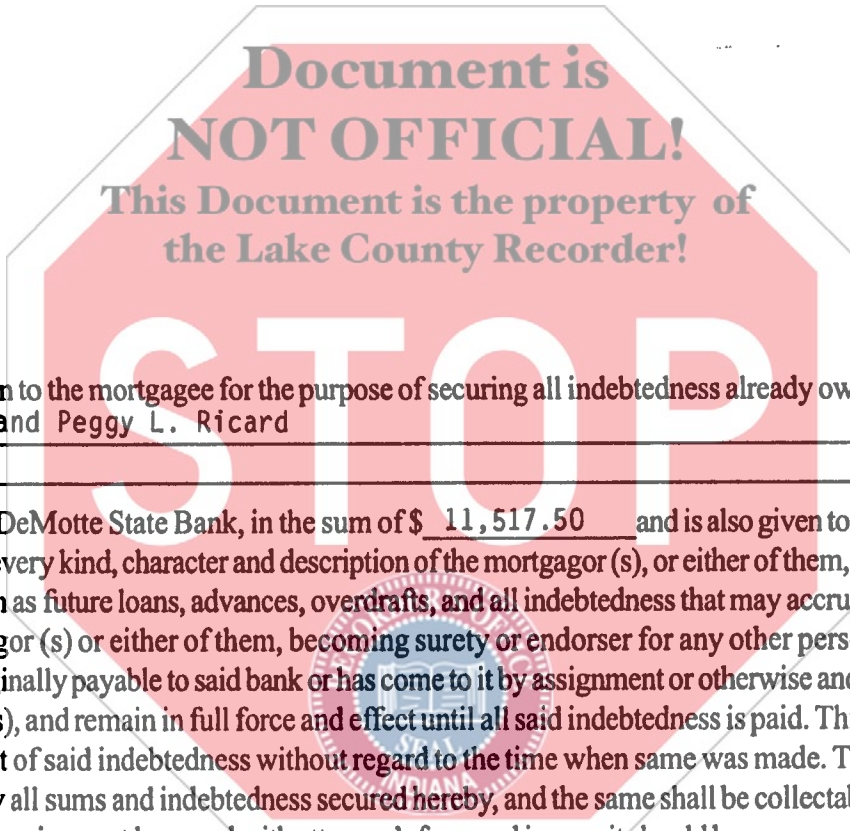
INDEMNIFYING MORTGAGE
