DEED INTO TRUST

THIS INDENTURE WITNESSETH that Robert J. Barr and Victoria J. Barr, husband and wife, of Lake County, State of Indiana ("Grantors"), for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, convey and transfer to Robert J. Barr, Jr. and Lorraine Barr, as Trustee of the Barr Revocable Living Trust U/T/A dated September 22, 2000, the following described real estate in Lake County, Indiana, to-wit:

Lot thirty-eight (38), Block one (1) Fifth Street Estates First Addition to the Town of Highland, as shown in Plat-Book 31, page 57, in Lake County, Indiana. Commonly known as 9027 Hess Drive, Highland, Indiana.

In the event of the resignation or incapacity of either Robert J. - (a) That at the time of the delivery thereof the trust created by the Trust Agreement was in full force and effect;
- (b) That such conveyance or other instrument was executed in accordance with the conditions and limitations contained in this deed and in the Trust Agreement or in any amendment thereof and binding upon all beneficiaries thereunder;
- (c) That the Trustee or his/her successor or successors in trust were duly authorized and empowered to execute and deliver every such deed, trust deed or other instrument; and
- (d) If the conveyance is made by or to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all of the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessors in trust.

Neither the Trustee nor his/her successor or successors in trust shall be personally liable upon any conveyance of the real estate, either by deed or mortgage. Any successor Trustee shall possess all of the powers herein granted to the original Trustee in the
