That part of Section 17, Township 36 North, Range 7 West of the 2nd Principal Meridian, in Lake County, Indiana, described as follows: Beginning at a point on the Northerly line of Central Avenue, in the City of Lake Station, Lake County, Indiana, which point is 2656.5 feet Westerly of the East line of said Section 17, as measured along the said Northerly line of Central Avenue; thence Northerly, along a line making a Northeast angle of 90 degrees with the Northerly line of Central Avenue, a distance of 294.27 feet, more or less, to the Southerly right of way line of the M.C.R.R.; thence Westerly and parallel to the M.C.R.R. right of way line a distance of 188.95 feet to a point of carrie; thence Westerly along a curve convex to the North with a radius of 2815.45 feet a distance of 580.78 feet, to a point of tangent with the Southerly right of way line of the former J.
