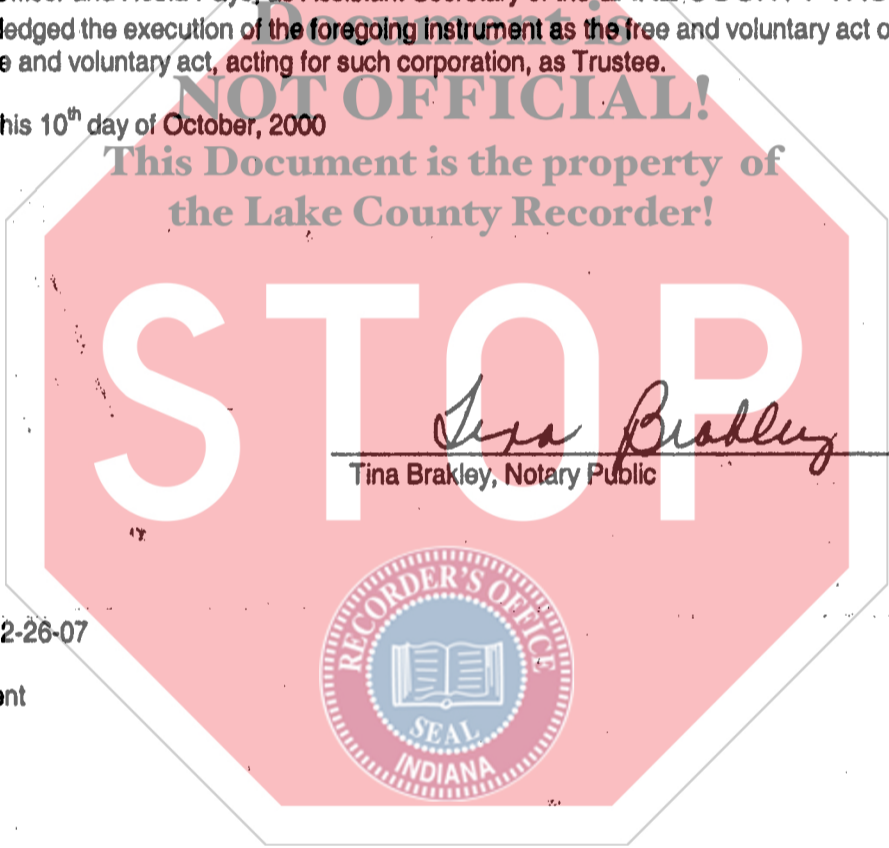

The West 102 feet of the North 66 feet of the following parcel: Part of the South half of the Northwest quarter of Section 8, Township 34 North, Range 8 West of the 2nd P.M., more particularly described as follows: Beginning at a point 800 feet West and 660 feet North of the Southeast corner of the Northwest quarter of said Section 8, said point being the Northwest corner of Eddy's Addition: Thence west and parallel with the South line of the Northwest quarter of said Section 8 along the South line of Mary C. Clark's Addition and along the South line of said Addition produced West a distance of 472 feet to a point 56.5 feet West of the Southwest corner of Mary C. Clark's Addition; thence South with an interior angle of  $90^{\circ}4'30''$  and parallel with the West line of Mary C. Clark's Addition produced South a distance of 79 feet; thence Southeasterly with an interior angle of  $159^{\circ}32'30''$  a distance of 105.61 feet; thence East parallel to the South line of Mary C. Clark's Addition and with an interior angle of  $110^{\circ}23'$  a distance of 435.59 feet, more or less, to the West line of Eddy's First Addition; thence North with an interior angle of  $90^{\circ}4'30''$  along the West line of Eddy's Addition a distance of 178 feet to the point of beginning, containing 1.887 acres, more or less; and , part of the South Half of the Northwest quarter of Section 8, Township 34 North, Range 8 West of the 2nd P.M., more particularly described as follows: Beginning at a point 800 feet West and 482 feet North of the Southeast corner of the Northwest quarter of said Section 8, said point being on the West line and 178 feet South of the Northwest corner of Eddy's First Addition; thence West and parallel to the South line of the Northwest quarter of said Section 8 a distance of 235.59 feet; thence South at right angles a distance of 20 feet; thence East parallel to the South line of the Northwest quarter of said Section 8 a distance of 85.56 feet, more or less, to the West line of Eddy's First Addition; thence North 20 feet to the point of beginning, containing 0.20 acres, more or less, containing in all 2.087 acres in the City of Crown Point, Lake County, Indiana.
