ASSIGNMENT OF AGREEMENTS

This Assignment of Agreements has been executed on the date of the acknowledgment hereto but shall be effective for all purposes as of July 19, 2000.

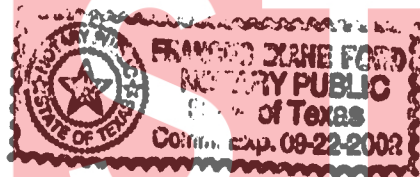

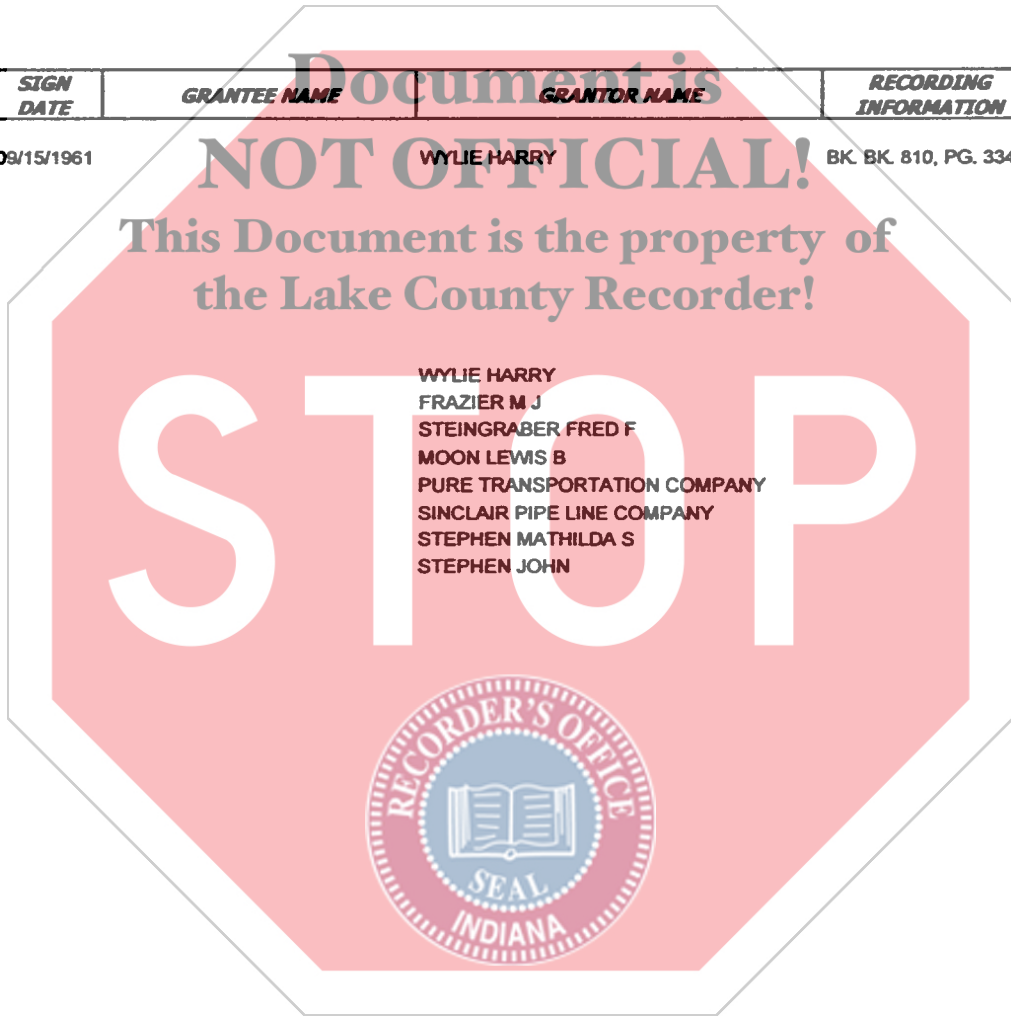
