ASSIGNMENT OF LETTER OF CREDIT AND REIMBURSEMENT AGREEMENT

THIS ASSIGNMENT OF LETTER OF CREDIT AND REIMBURSEMENT AGREEMENT (this "Assignment") is made as of this 19th day of December, 1996, by and among MARINE MIDLAND BANK, a New York banking corporation formerly known as Marine Midland Bank, N.A. ("Marine Midland"), LASALLE NATIONAL BANK, a national banking association ("LaSalle"), and TRI-CITY COMMUNITY MENTAL HEALTH CENTER, INC., a nonprofit corporation organized and existing under the laws of the State of Indiana and formerly known as Tri-City Comprehensive Community Mental Health Center, Inc. ("Tri-City").

RECITALS:

- A. Marine Midland and Tri-City are parties to a certain Letter of Credit and Reimbursement Agreement dated as of October 1, 1990 (the "Reimbursement Agreement"), pursuant to which Tri-City agreed to reimburse Marine Midland in full for any and all funds paid by Marine Midland on behalf of Tri-City pursuant to that certain Irrevocable Letter of Credit issued by Marine Midland dated November 29, 1990 (the "Marine Letter of Credit").
