KNOW ALL MEN BY THESE PRESENTS:

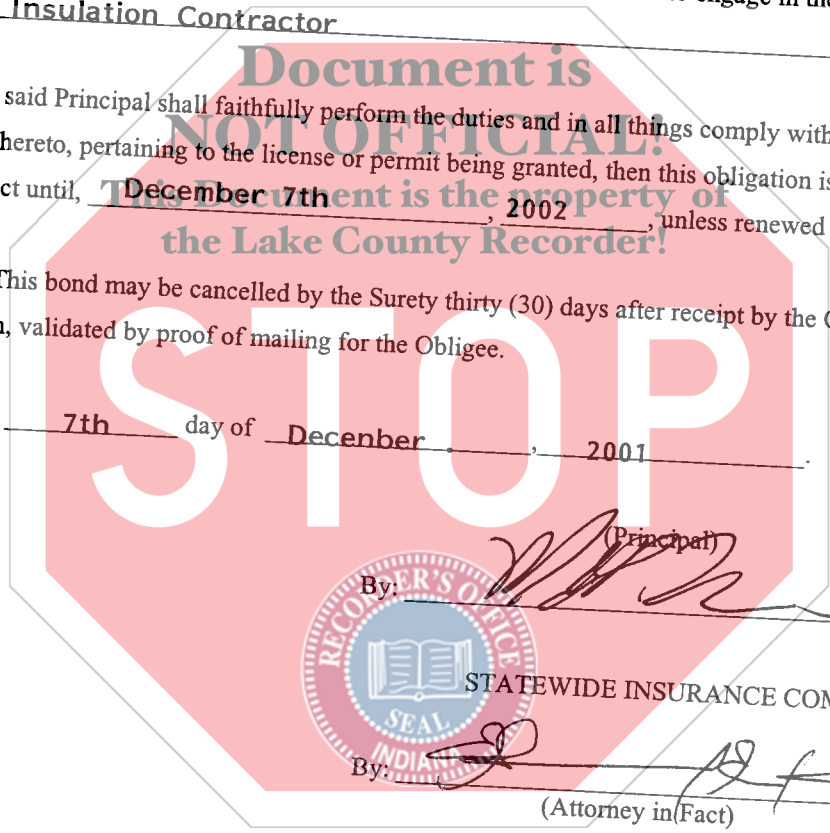

POWER OF ATTORNEY
