SATISFACTION OF MORTGAGE

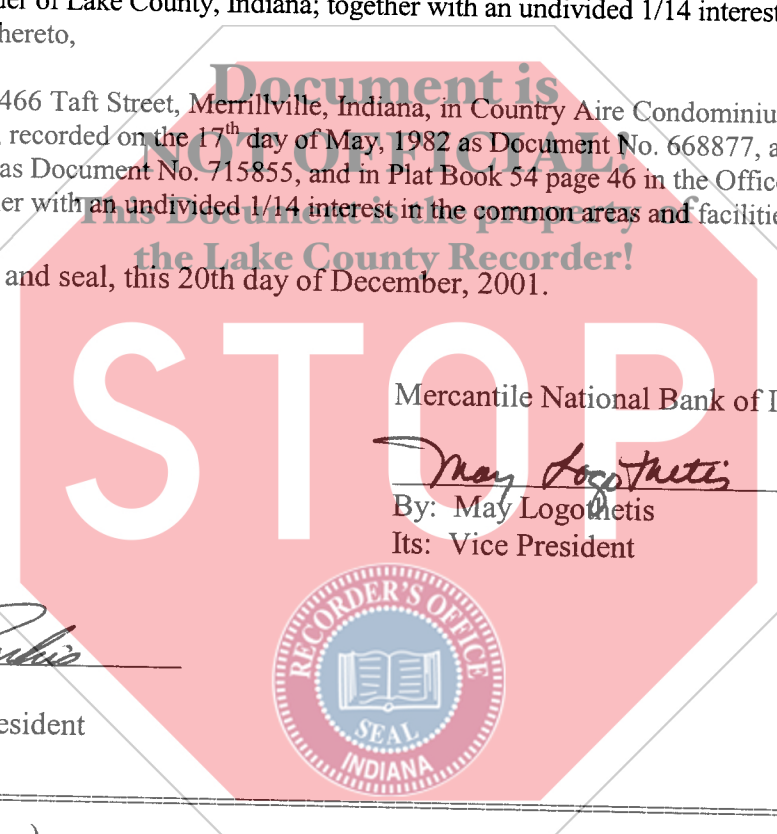
