DECLARATION OF RESTRICTION ON LAND USE

This Declaration is made as of the 8th day of November 2001 by Feather Rock, L.L.C., an Indiana limited liability company ("Owner").

Owner is the title holder of certain property located in the City of Crown Point, Lake County, Indiana, Sections 19 & 20, Township 34N, described on attached Exhibit A (the "Property").

The Property contains areas which have been identified as waters of the United States, including wetlands, as defined in regulations promulgated pursuant to Section 404 of the Clean Water Act (33 CFR 328.3(b)).

Owner desires to obtain viable use of the Property, but any such activity requires certain improvements being constructed in portions of the waters of the United States.

The locations of the improvement area is shown collectively as Exhibit B (the "Site Plan").

Owner has agreed to voluntarily restrict any activities in the wetland areas, identified as Preserved Area, on the Property, as shown on the Site Plan.order!

Owner has agreed to minimize detriments to aquatic resources in the preserved area in exchange for, and as condition to authorization of the improvements by the Department of the Army, United States of America, Corps of Engineers ("ACOE").

Owner hereby declares and covenants that no discharge of dredged or fill material other modification or development of the preserved area shall be undertaken. Owner will ensure to the best of their ability, that vegetation, soils, and hydrology of the preserved area shall remain in an unaltered, natural condition.

The restriction and covenant herein shall be perpetual, and shall be binding upon the Owner and their legal representatives, heirs and assigns. The ACOE and its successors and designees, shall have the right to enforce any of the provisions contained herein against their legal representatives, heirs and assigns.




