LEGAL DESCRIPTION

Part of the Northeast Quarter of Section 33, Township 32 North, Range 8 West of the Second Principal Meridian, In Lake County, Indiana, more particularly described as follows: Beginning at the Northwest corner of the Northeast Quarter of said Section 33; thence South along the West line of said Northeast Quarter a distance of 1180 feet; thence East parallel with the North line of said Northeast Quarter a distance of 299.8 feet; thence South 24 degrees 12 minutes East a distance of 752.4 feet; thence South 4 degrees 35 minutes East, to the North bank of the Marble-Power Ditch, 34 feet; thence North 87 degrees 37 minutes East along the North bank of the Marble-Power Ditch a distance of 1105.5 feet to a point that is the beginning point of this description; thence North 87 degrees 37 minutes East along the North bank of the Marble-Power Ditch a distance of 100 feet; thence North 2 degrees 23 minutes West a distance of 86 feet; thence South 85 degrees 3 minutes West parallel with the Brown Dike a distance of 100 feet; thence South 2 degrees 23 minutes East, to the place of beginning, 80 feet, EXCEPTING a strip of land 20 feet wide and 100 feet long, 60 feet from the North bank of the Marble-Power Ditch and parallel with it, reserved for a public road. 503630/16027
