That on 11/21/2001, the owner(s) owned the following described land in the County of Lake, State of Indiana to wit:

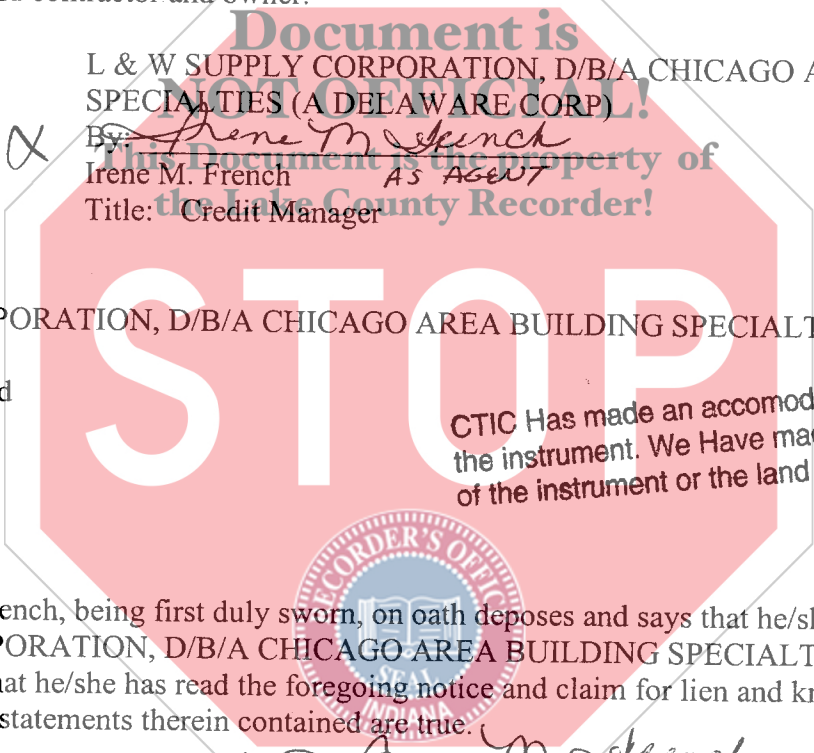
