 the 31st day of December, 2002, and until his successor is duly qualified.

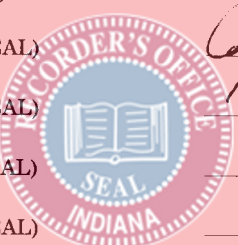
NOW THEREFORE, if the said Principal shall faithfully discharge and perform his duties as such

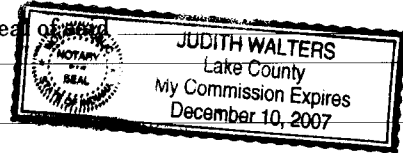

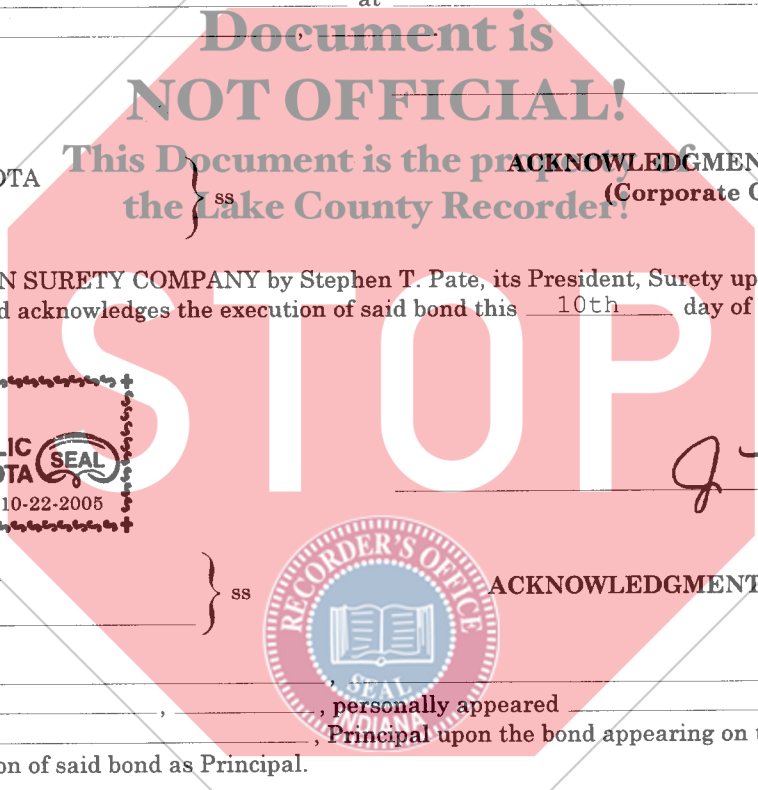

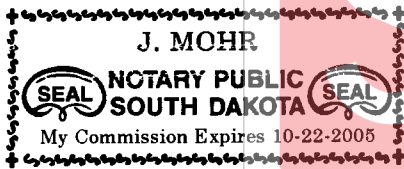
