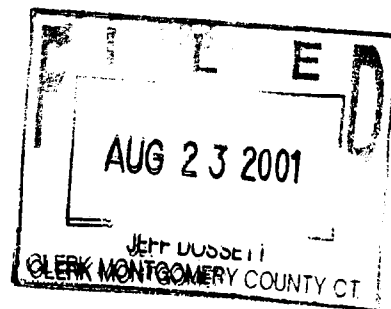

IT IS FURTHER ORDERED that the plaintiff release this judgment within seven (7) days of satisfaction.

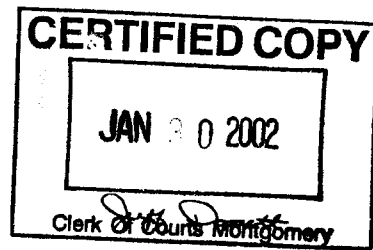
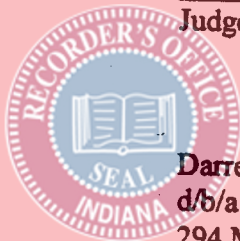
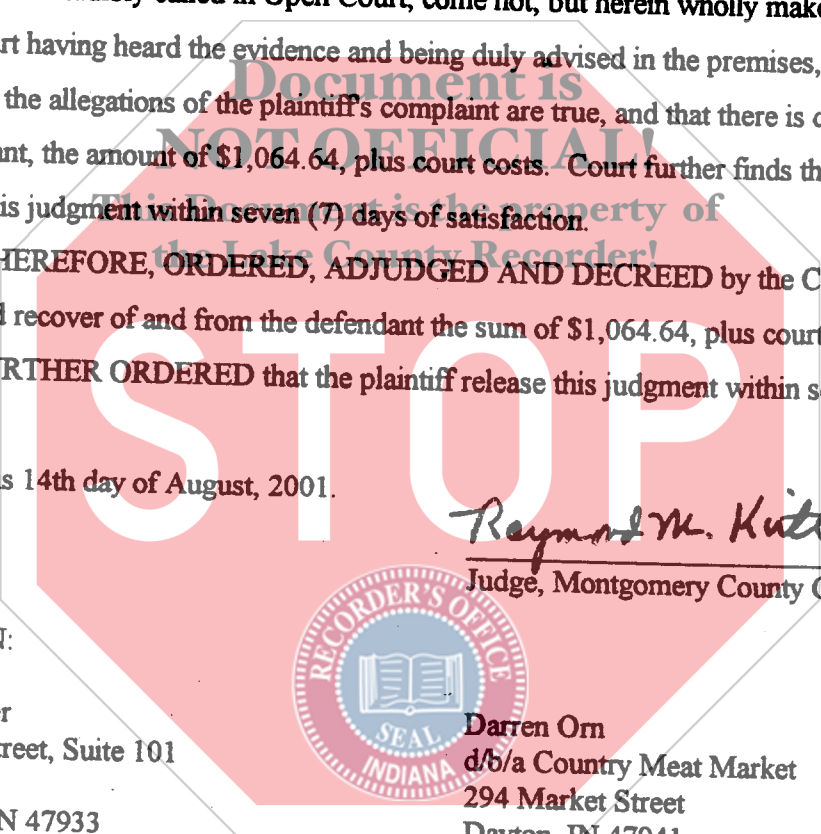
