# TAX TITLE DEED TO COUNTY

Whereas the Lake County Board of Commissioners did the 4th day of February, 2002 produced to the County of Lake, in the State of Indiana, a certificate of sale dated the 03/30/2001, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that said County on the 03/30/2001, obtained, pursuant to law, the real property described in this indenture for the sum of FOUR HUNDRED THIRTY-EIGHT AND 28/100 DOLLARS (\$438.28) being the amount due on the following tracts of land returned delinquent in the name GILLILAND, WILLIAM H for 1999 and prior years, namely:

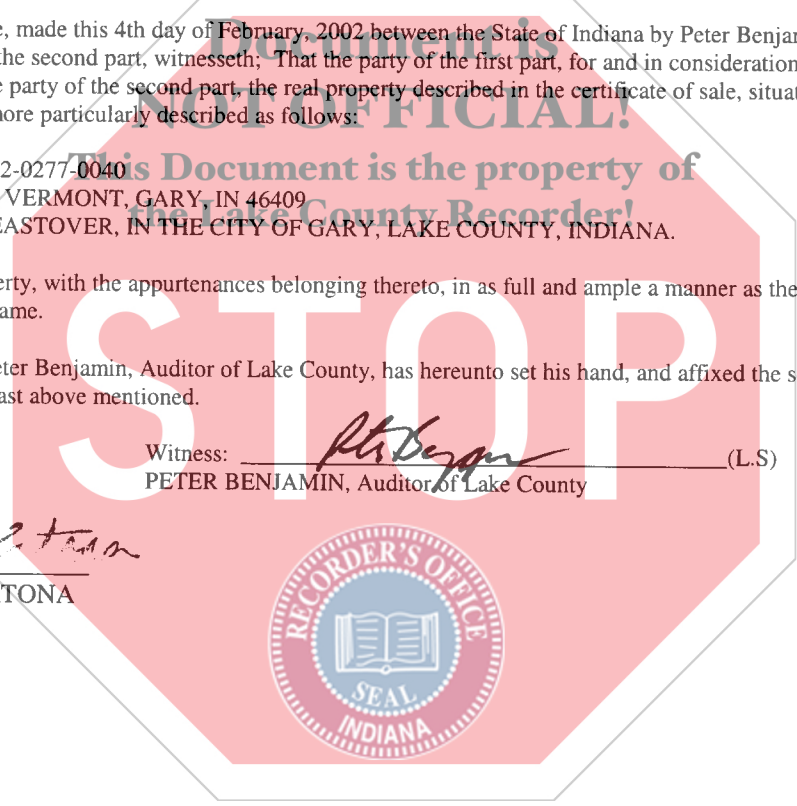
