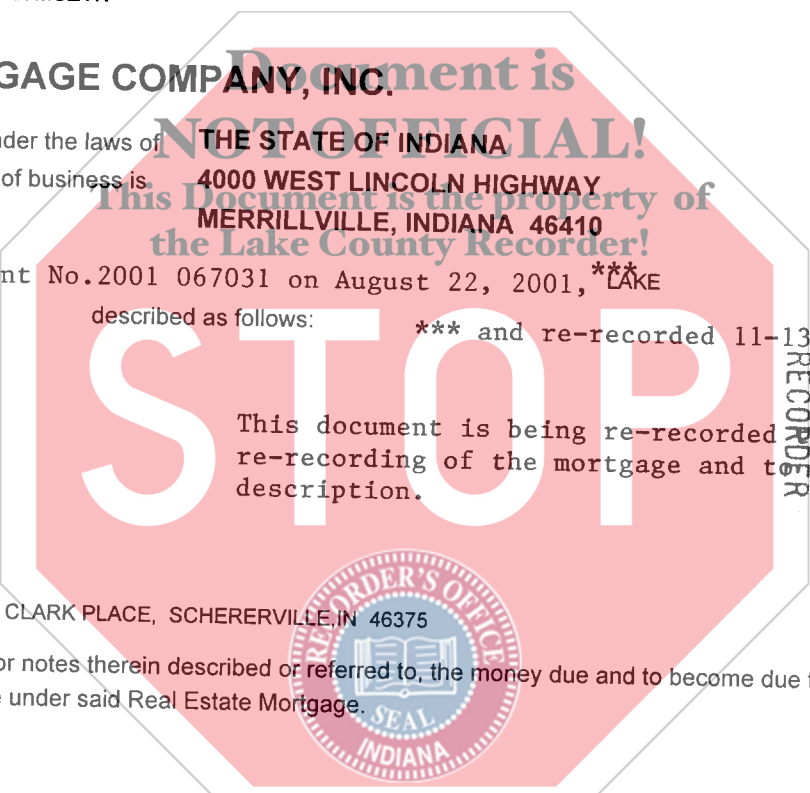

## LEGAL DESCRIPTION

Lot 27, Schererville Trace II, an Addition to the Town of Schererville, as per plat thereof, recorded in Plat Book 81 page 46 and amended by a Certificate of Correction recorded October 30, 1996 as Document No. 96072262 and by a Certificate of Correction recorded November 1, 1996 as Document No. 96072971, in the Office of the Recorder, Lake County, Indiana, except the following described parcel:

Beginning at the Northwest corner of said Lot 27, thence South 54 degrees 24 minutes 18 seconds East along the Northerly line of said Lot 27, a distance of 139.48 feet to the Northeast corner of said Lot 27; thence South 45 degrees 30 minutes 07 seconds West, along the East line of said Lot 27, a distance of 48.73 feet; thence North 54 degrees 24 minutes 18 seconds West, a distance of 134.14 feet to a point on a curve; thence Northeast along said curve being concave to the Northwest, having a radius of 380.00 feet and an arc distance of 48.13 feet to the point of beginning, all in the Town of Schererville, Lake County, Indiana.
