Death, for Appointment of Personal Representative and for Supervised Administration,
which Petition is in the following words: (H.I.)

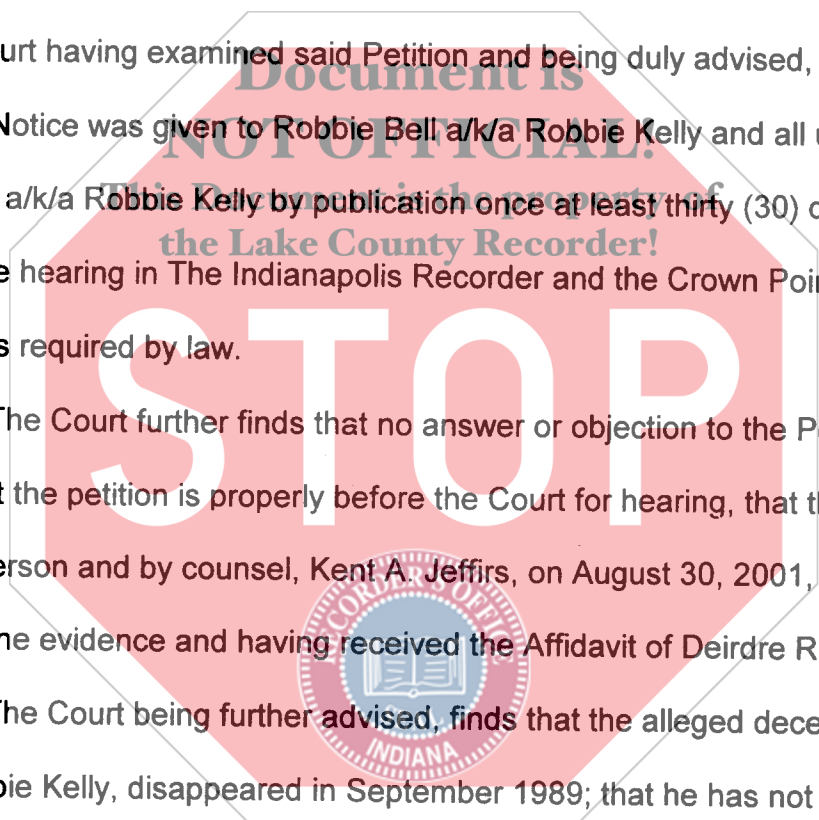
The Court having examined said Petition and being duly advised, **NOW FINDS:**

1. Notice was given to Robbie Bell a/k/a Robbie Kelly and all unknown heirs
of Robbie Bell a/k/a Robbie Kelly by publication once at least thirty (30) days prior to the
date set for the hearing in The Indianapolis Recorder and the Crown Point Star
newspapers as required by law.

2. The Court further finds that no answer or objection to the Petition has
been filed, that the petition is properly before the Court for hearing, that the Petitioner
appeared in person and by counsel, Kent A. Jeffers, on August 30, 2001, with the Court
having heard the evidence and having received the Affidavit of Deirdre R. Harris.

3. The Court being further advised, finds that the alleged decedent, Robbie
Bell a/k/a Robbie Kelly, disappeared in September 1989; that he has not been heard
from, either directly or indirectly, from that date to the date of this hearing on August 30,
2001.

4. The Court further finds, pursuant to I.C. 29-2-5-1, Robbie Bell a/k/a Robbie Kelly has been absent from his usual place of residence and gone to parts unknown for a period in excess of five (5) years, without having made any sufficient provision for the care and management of his real property.

5. The Court therefore finds that Robbie Bell a/k/a Robbie Kelly died intestate on August 30, 2001, at the time of his death was domiciled in Lake County, Indiana, and that he left surviving him the following heir at law: Deirdre R. Harris, Sister.

6. That Deirdre R. Harris should be appointed as Personal Representative of the decedent's Estate.

7. Letters should be issued as indicated and requested in such Petition.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court:

1. The notice provisions and evidentiary requirements of I.C. 29-2-5-1 have been satisfied and that the decedent is hereby presumed and declared dead, having died on August 30, 2001.

2. The decedent left surviving him as his only heirs at law as provided under I.C. 29-1-2-1, the following individuals: Deirdre R. Harris, Sister.

3. Deirdre R. Harris, is hereby appointed Personal Representative of the Estate of Robbie Bell a/k/a Robbie Kelly.

4. Said Personal Representative shall serve upon taking an oath and that said Personal Representative shall serve without the posting of bond.

5. The Clerk be and is hereby directed to issue Letters of Administration to Deirdre R. Harris, upon her qualification.

Comes now said Personal Representative and qualifies by filing her Acceptance and Oath. *Bond in the sum of \$16,500. to be posted.*

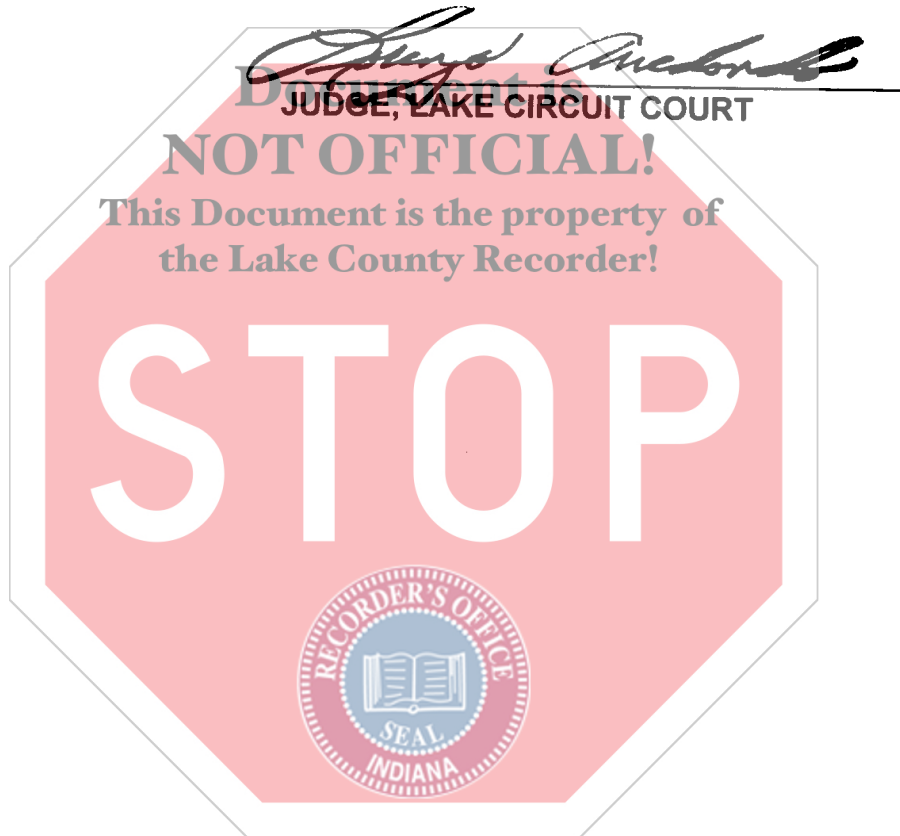
