SUPERIOR COURT REAL ESTATE BOND

State v. Jarvis Green MORRISFIELD ARTER RECORDER Case: 456040202FB-0013

We, Jarvis Brown (Full Legal Name of Defendant) and Dora E. Brown n.k.a. George (Name of Real Estate Owner)

hereby acknowledge ourselves bound to the State of Indiana in the total amount of \$ 32,000.00 Dollars and pledge as security the property described in the attached printout from the office of the Auditor of Lake County.

If the defendant shall appear on the day of March 21, 2002, 1902 at 8:30 a.m., before the Commissioner of the Superior Court, Criminal Division, or before the presiding judge if the defendant has already had an initial hearing, to answer the charge in this case, and shall appear from day to day thereafter as may be required, and shall satisfy all fees, fines and restitution which may be adjudged against him, then this bond shall be void. If the defendant does not appear at the time fixed in this bond, or at any time thereafter ordered by the court, then this bond shall be forfeited and a warrant will be issued for the defendant's arrest. If the defendant is not personally present when the court sets the next date for him to appear, the clerk shall only be required to notify him of that date, or of the forfeiture of this bond, at the address given below. Unless the defendant is immediately surrendered to the court following the forfeiture of this bond, and unless the court finds there was legal justification for his failure to appear, then the court shall immediately enter judgment against us for the full amount of the bond. Such forfeiture shall be without pleadings and without change of judge or change of venue. Upon further order of the court, an execution of judgment shall issue to the sheriff against the properties of the defendant and surety to be levied as other executions are levied.

The defendant acknowledges that he may not leave the State of Indiana without permission of the court. The defendant's signature on this bond shall be held a waiver of extradition proceedings in any state, territory or country in which he may be found; and the Sheriff of Lake County or other state law enforcement officer may take him into custody without further orders or proceedings in this jurisdiction or the jurisdiction in which he is found.
