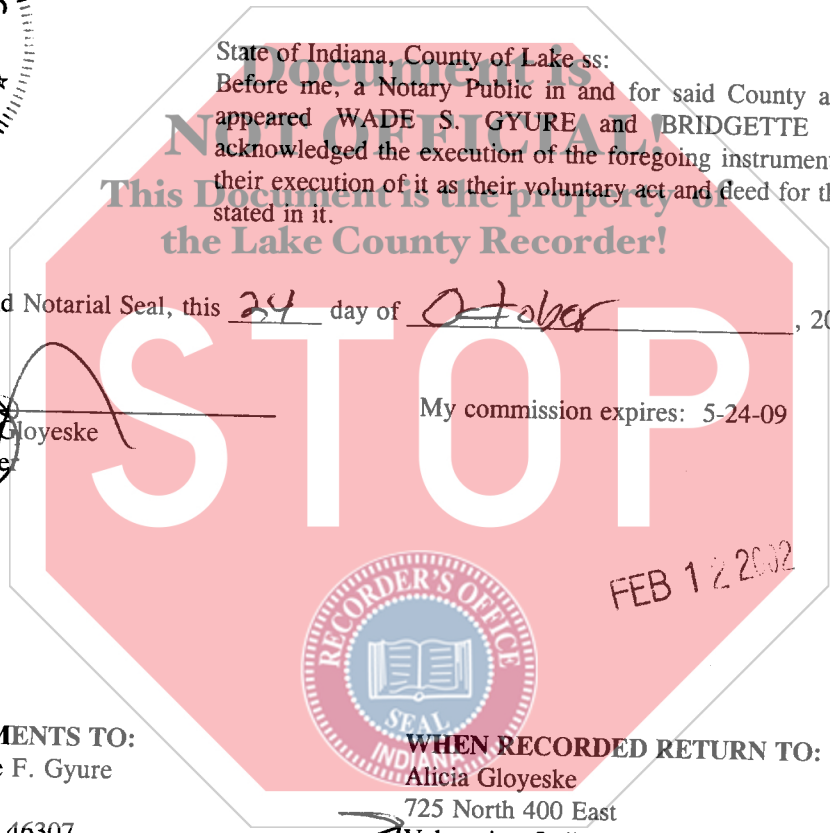

Except the South 329.24 feet of the East 435.60 feet thereof.
