Wanda L. Brown Turner a/k/a Wanda L. Jackson of Lake County in the State of Indiana,

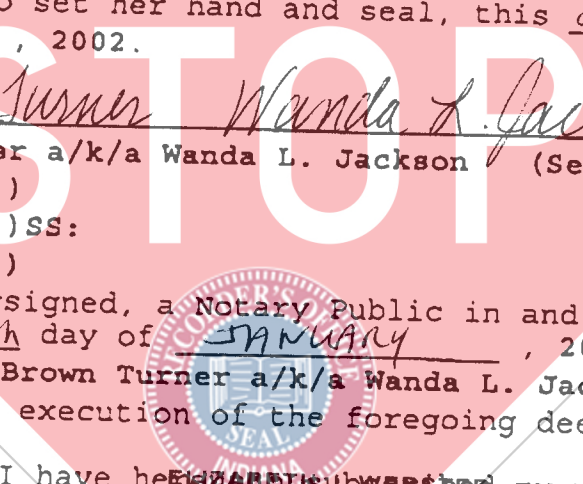
CONVEYS AND WARRANTS TO:
