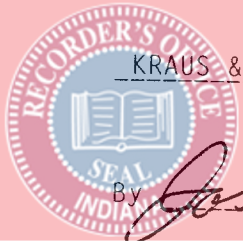
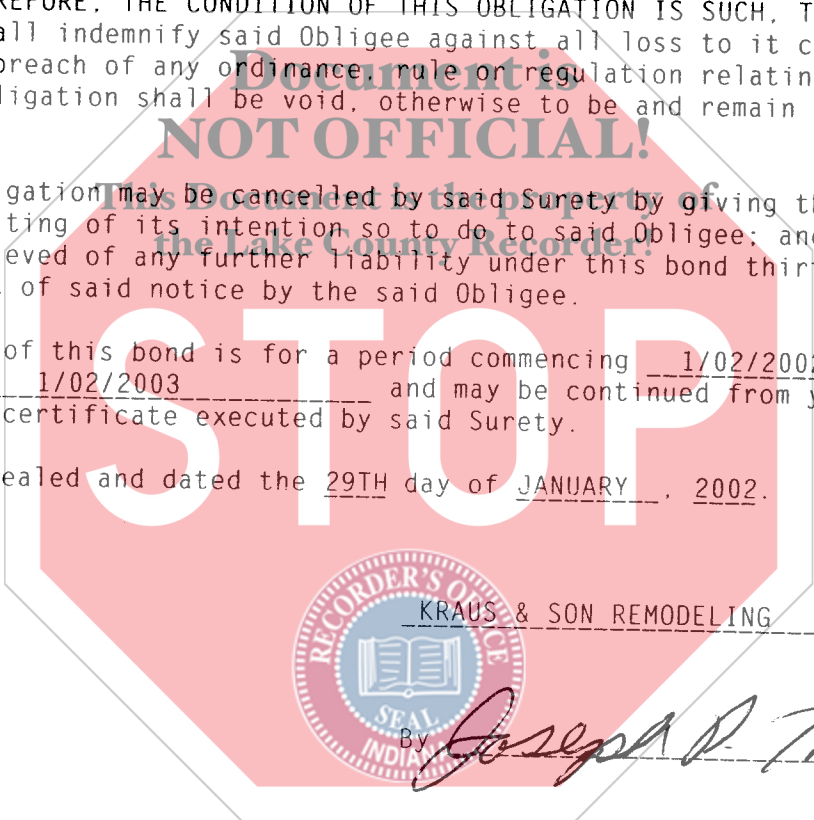
WHEREAS, the said Principal has applied to said Obligee for a license to or permit as a CARPENTRY CONTRACTOR

RESOLVED FURTHER that any bond, undertaking, recognizance, or suretyship obligation shall be valid and binding upon the Company


