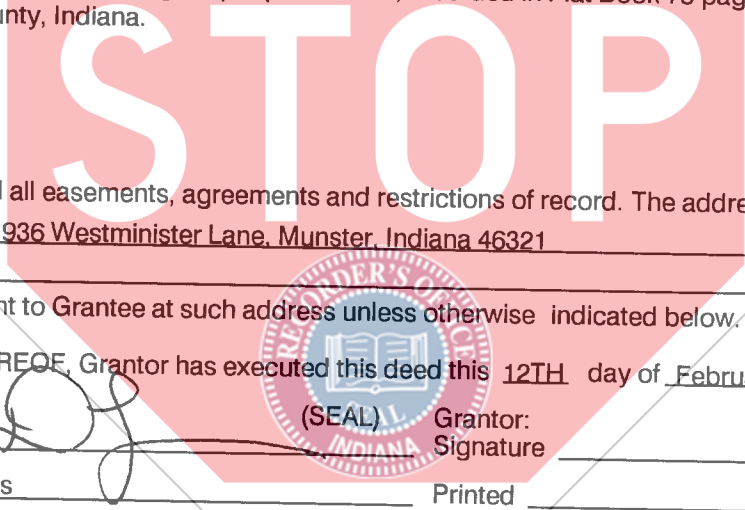
THIS INDENTURE WITNESSETH, That TOM D. LARGUS
