SHERIFF'S DEED ON DECREE

THIS INDENTURE, made this 1st day of February, A.D., 2002, between John Buncich, Sheriff of Lake County, in the State of Indiana, of the first part, and the BANK CALUMET (formerly known as CALUMET NATIONAL BANK) of the County of Lake and State of Indiana of the second part. WITNESSETH:

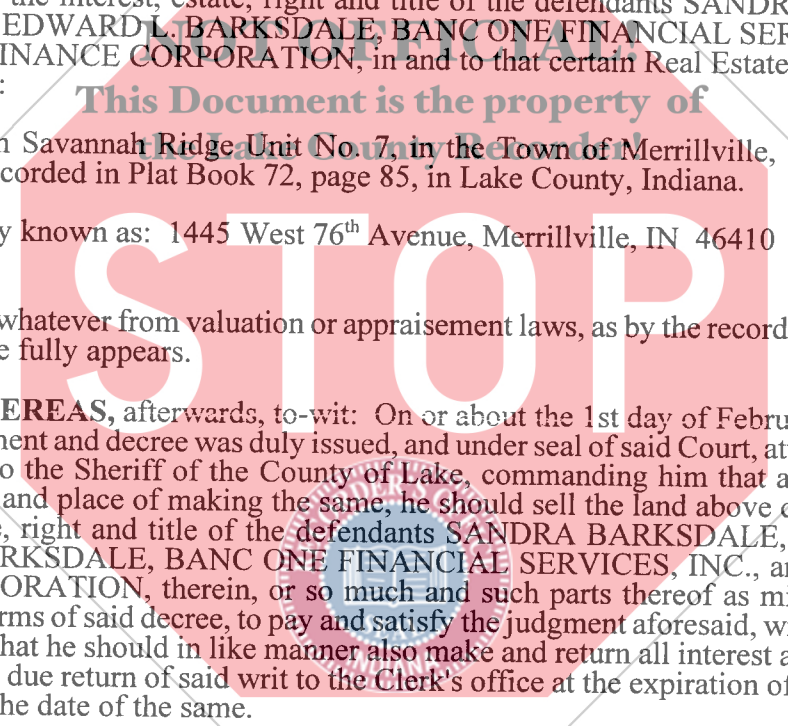
THAT WHEREAS, at the Continuous Term of the Lake Superior Court, A.D., 1999, BANK CALUMET (formerly known as CALUMET NATIONAL BANK) recovered by judgment of said Court, in a certain action therein against SANDRA BARKSDALE the sum of \$125,000.00, together with interest and the further sum of \$16.00 for Sheriff's costs in that behalf expended; and a decree for the sale of all the interest, estate, right and title of the defendants SANDRA BARKSDALE, LALLIE NUNN, EDWARD L. AND WHEREAS, afterwards, to-wit: On or about the 1st day of February, A.D., 2002, a copy of said judgment and decree was duly issued, and under seal of said Court, attested by the Clerk thereof, directed to the Sheriff of the County of Lake, commanding him that after due and legal notice of the time and place of making the same, he should sell the land above described, with all the interest, estate, right and title of the defendants SANDRA BARKSDALE, LALLIE NUNN, EDWARD L. 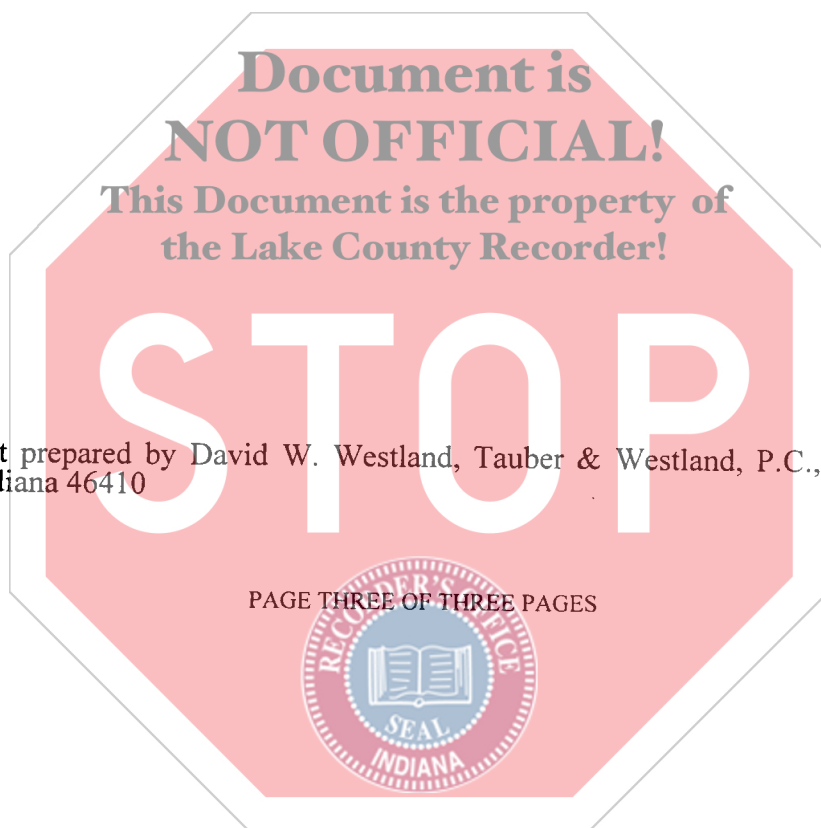
