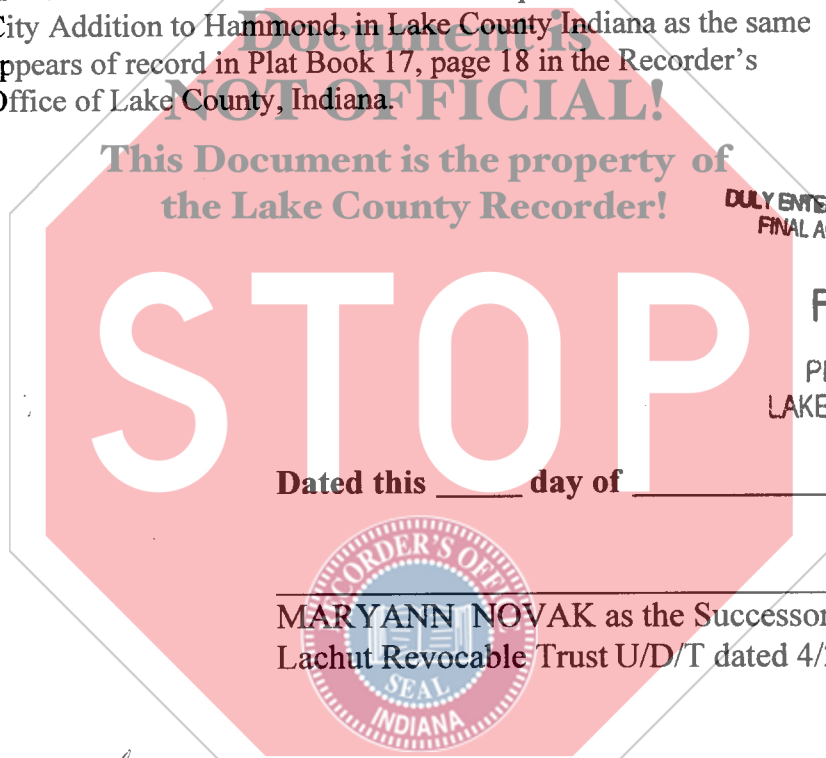

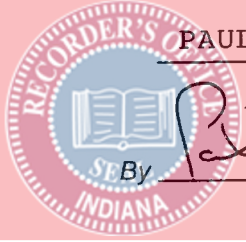
for a term beginning DECEMBER 31, 2001 and ending DECEMBER 30, 2002
