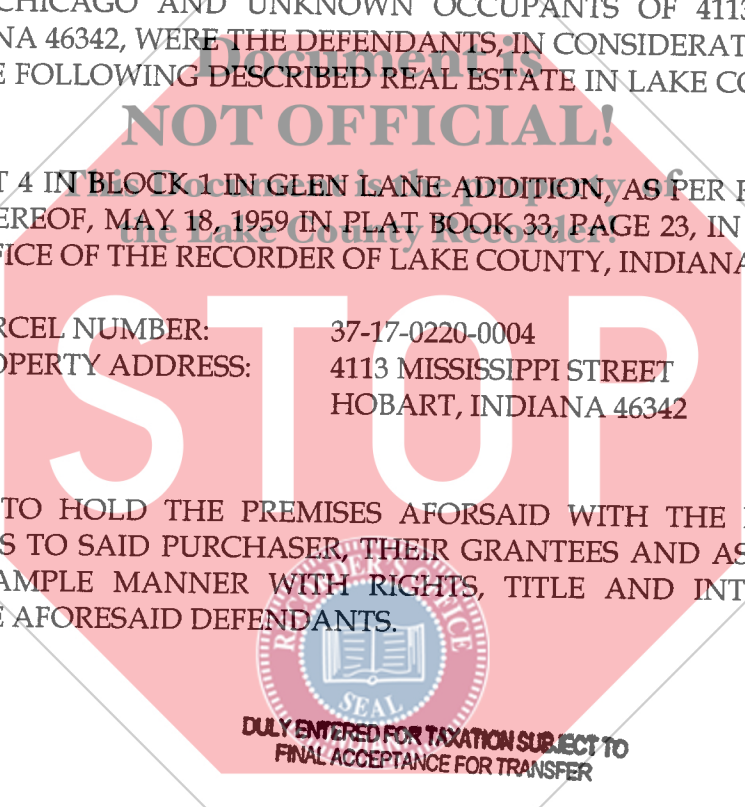
SHERIFF'S DEED
