THAT PART OF LOT 8 IN UNIT 3, BARRINGTON RIDGE, A PLANNED UNIT DEVELOPMENT IN THE CITY OF HOBART, AS PER PLAT THEREOF, RECORDED IN PLAT BOOK 75 PAGE 63, IN THE OFFICE OF THE RECORDER OF LAKE COUNTY, INDIANA, BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT THE MOST NORTHERLY CORNER OF SAID LOT 8; THENCE SOUTH 36 DEGREES 27 MINUTES 40 SECONDS EAST ALONG THE NORTHEASTERLY LINE OF SAID LOT 8 A DISTANCE OF 195.43 FEET, TO THE POINT OF BEGINNING; THENCE SOUTH 36 DEGREES 27 MINUTES 40 SECONDS EAST 64.57 FEET, TO THE MOST EASTERLY CORNER OF SAID LOT 8; THENCE SOUTH 53 DEGREES 32 MINUTES 20 SECONDS WEST ALONG THE SOUTHEASTERLY LINE OF SAID LOT 8, TO A POINT OF CURVE; THENCE WESTERLY 59.17 FEET ALONG THE SOUTHERLY LINE OF SAID LOT 8, BEING THE ARC OF A CIRCLE OF 90.00 FEET RADIUS CONVEX SOUTHERLY, TO THE MOST SOUTHERLY CORNER OF SAID LOT 8; THENCE NORTH 36 DEGREES 27 MINUTES 40 SECONDS WEST 45.81 FEET; THENCE NORTH 53 DEGREES 32 MINUTES 20 SECONDS EAST 100.00 FEET, TO THE HEREIN DESIGNATED POINT OF BEGINNING.

2. All covenants, easements, assessments and restrictions now of record.


