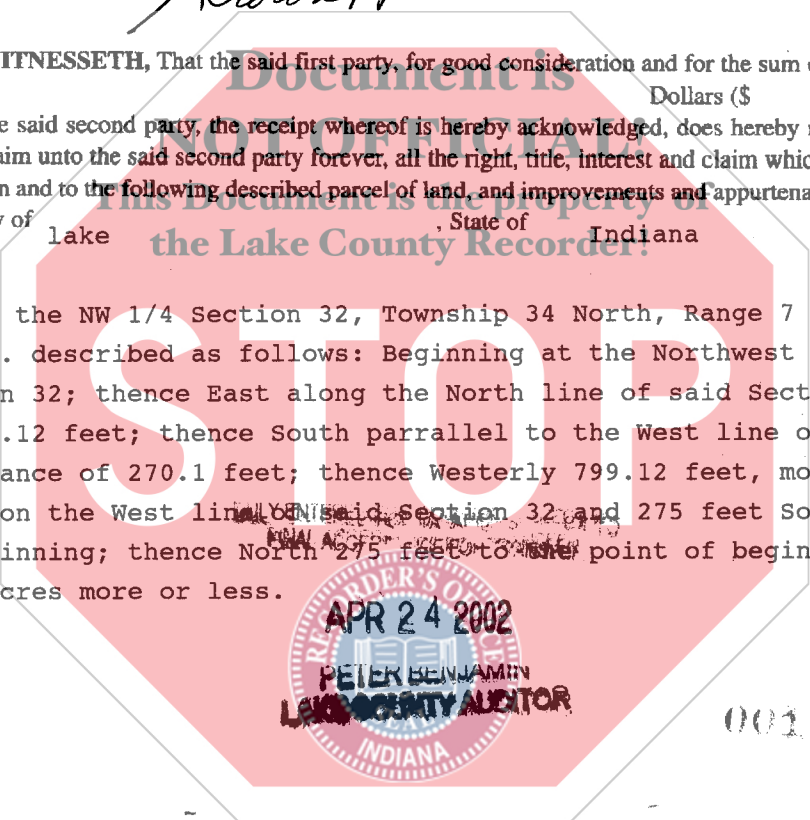
QUITCLAIM DEED

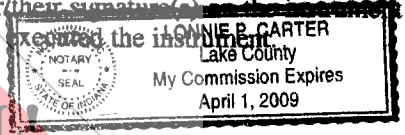
