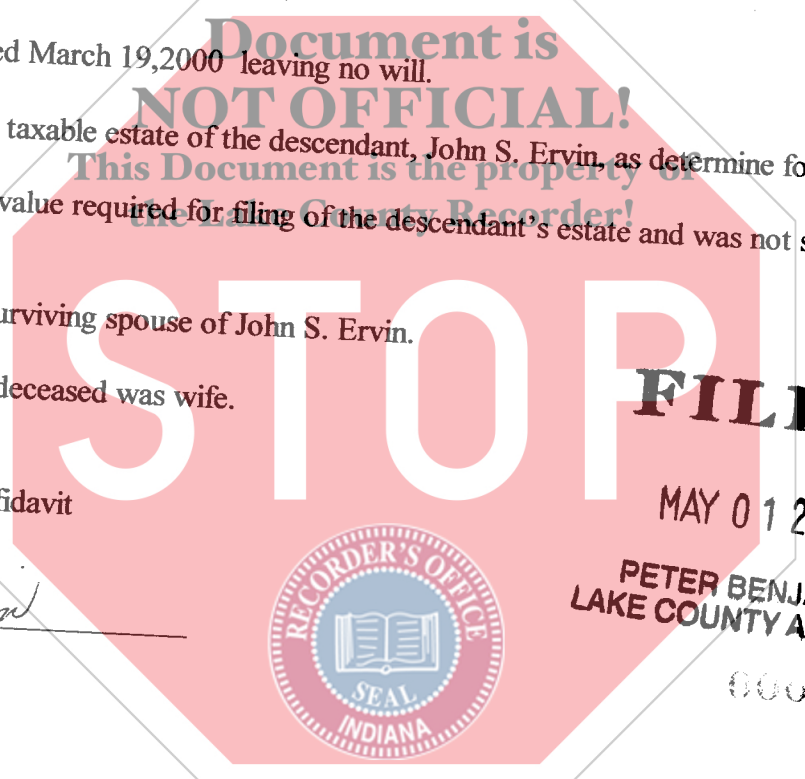
Comes now Rene A. Ervin being duly sworn upon her oath states as follows:

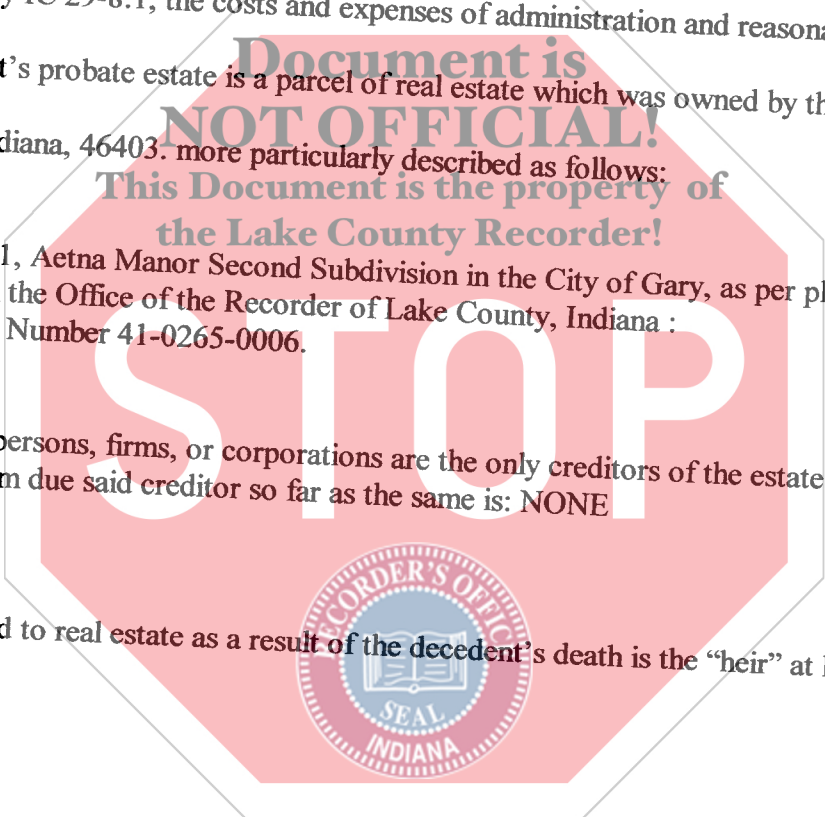

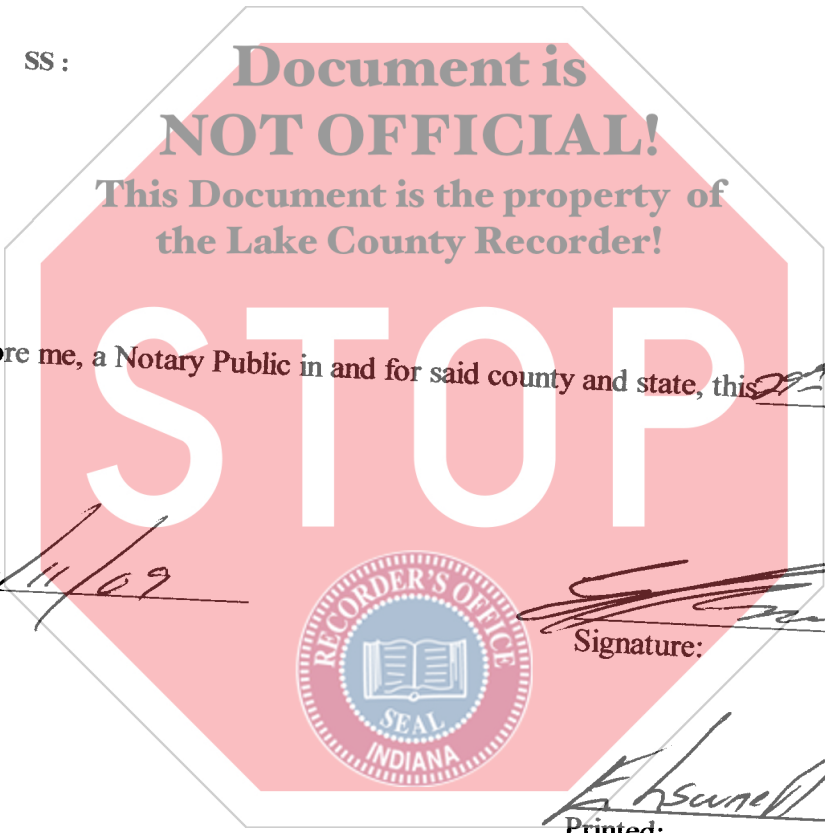
