then this Obligation shall be null and void, otherwise to remain in full force and effect.

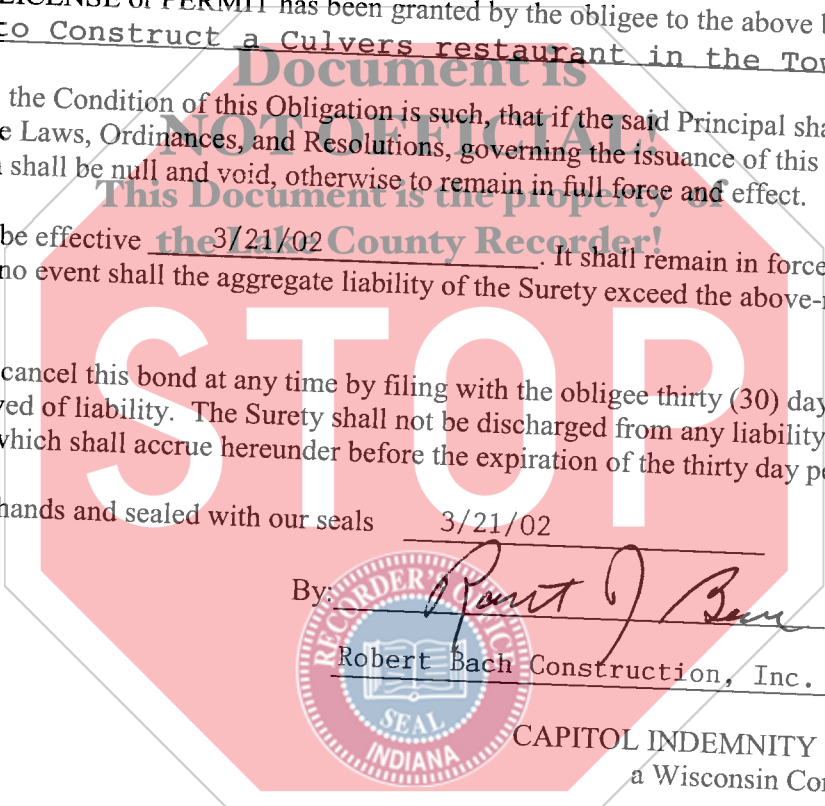
This bond shall be effective 3/21/02. It shall remain in force until cancelled as

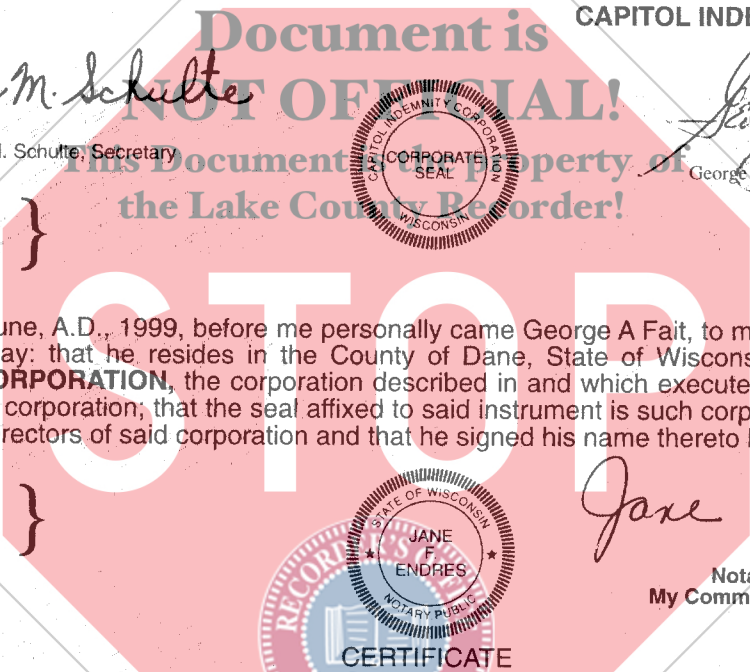
