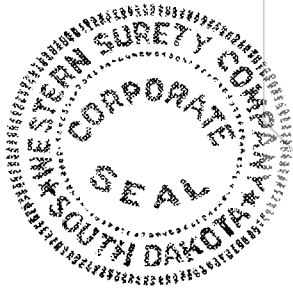
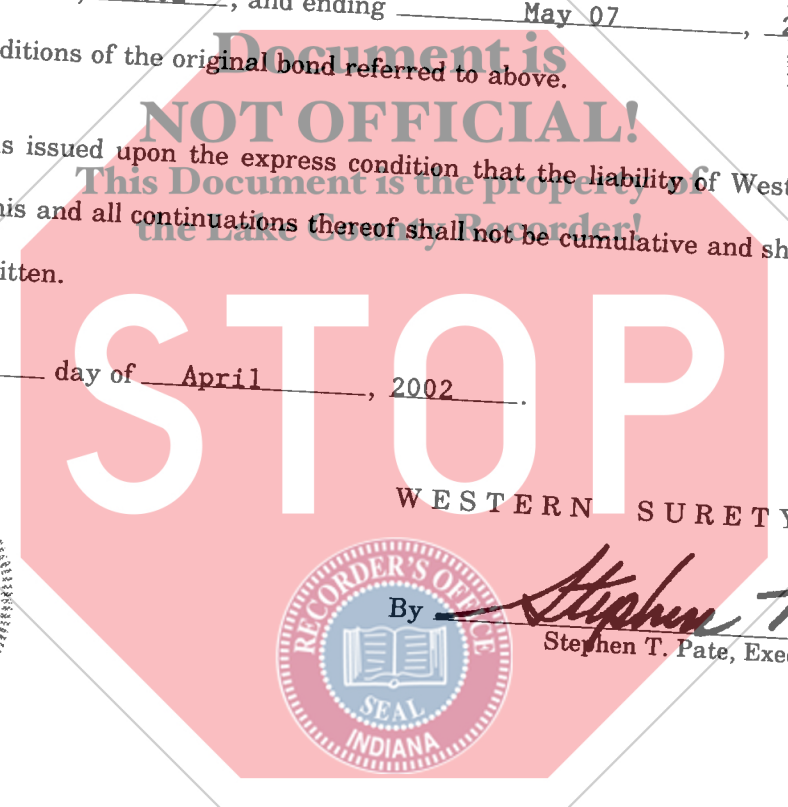

## POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

The corporate seal is not necessary for the validity of any bonds, policies, undertakings, Powers of Attorney or other obligations of the corporation. The signature of any such officer and the corporate seal may be printed by facsimile.
