As of 04/19/2002, the obligor owes unpaid support in the amount of \$31,925.29. This judgment may be subject to interest.

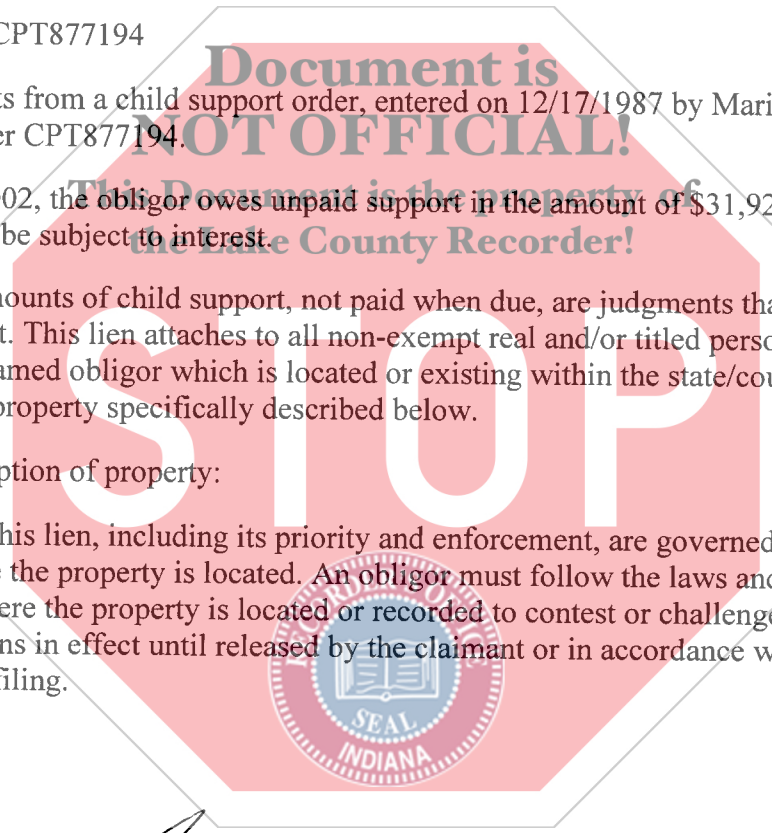
