1. On February 10, 2001, IRENE STUCKERT died domiciled in Lake County, Indiana, leaving a Will. Letters Testamentary were granted to GERALDINE LUDWIG on March 26, 2001 and the notice of the issuance thereof was duly given as provided by law.
2. More than five months have elapsed since the date of the first published notice to heirs and creditors.
3. Neither the decedent nor the Personal Representative as such were employers of labor within the meaning of that term as used in the Indiana Employment Security Act.
