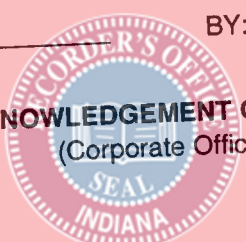
1. This obligation may be extended from year to year at the option of the Surety, by continuation certificate executed by the Surety;

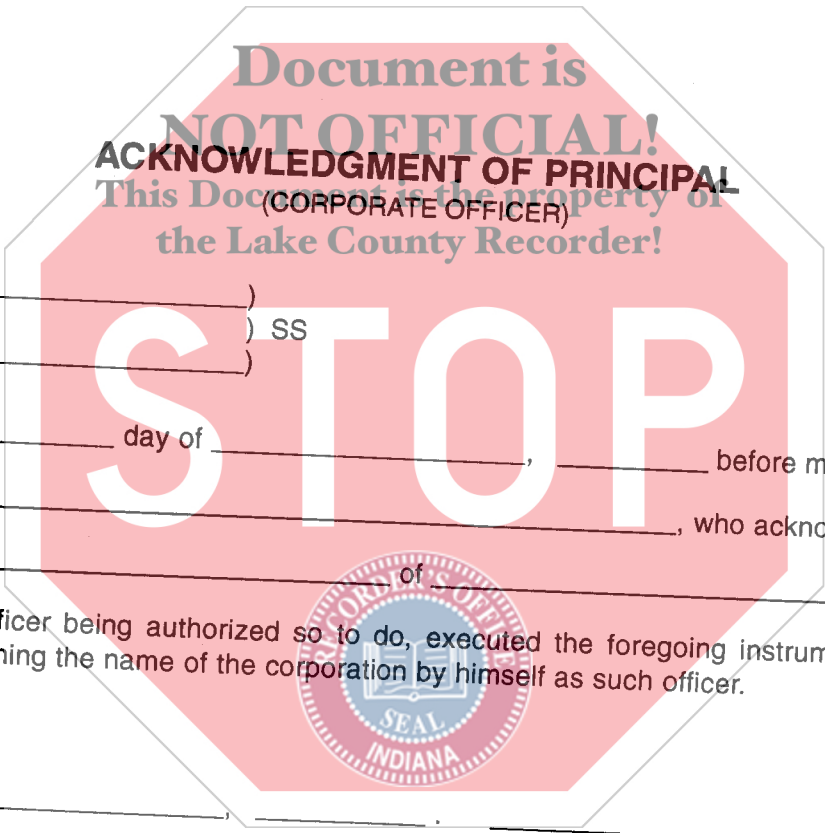
