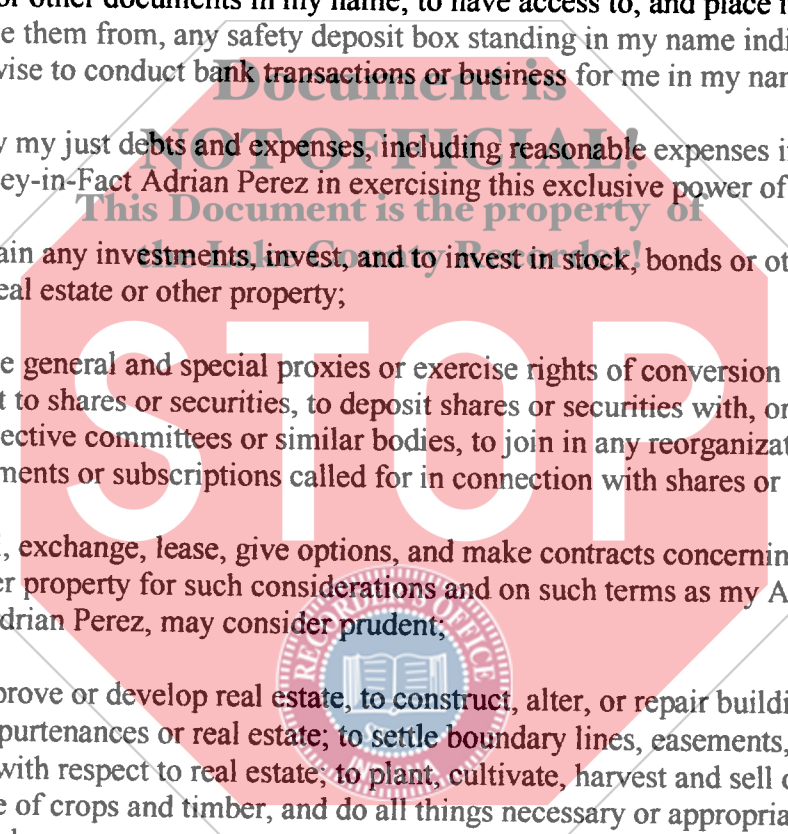

POWER OF ATTORNEY

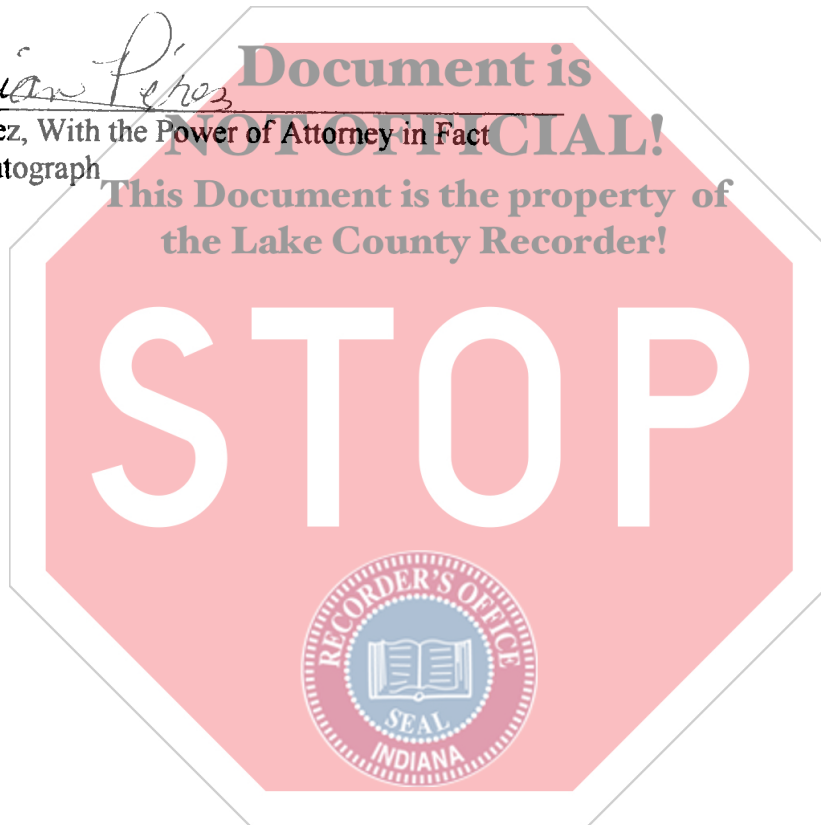


