Subject to all restrictions and limitations now of record, and to all taxes, easements, mortgages, restrictions and right of ways of record, if any.

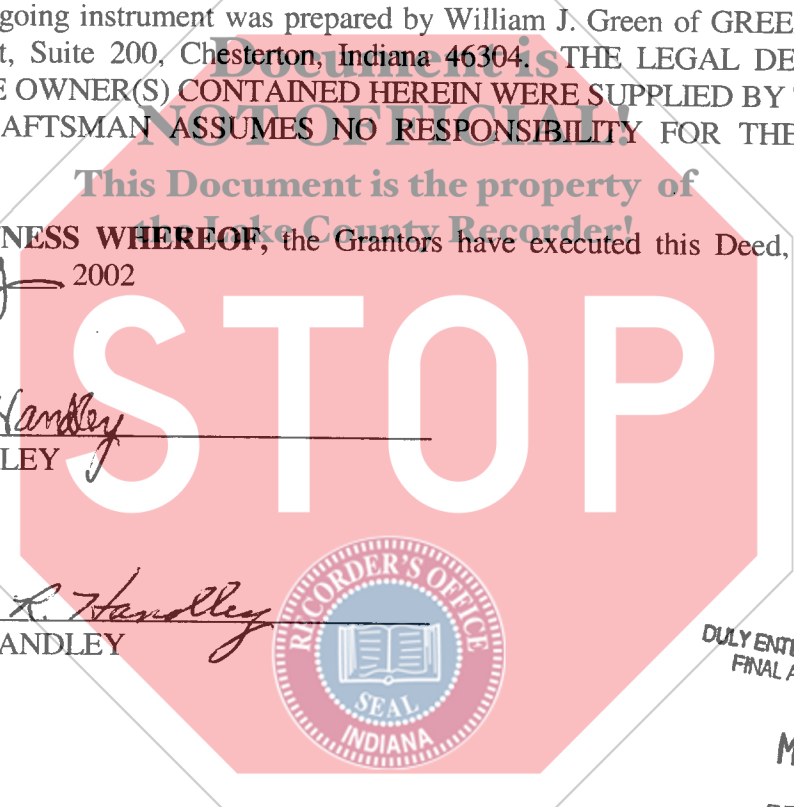
